Sir,

I have the honour to state that today i.e. 15/12/2025 at about 01:45 pm, a reliable information was received from our own source and further corroborated from the information input provided by 31 AR regarding the presence of some active cadres of PREPAK organization, an outlawed banned organization, in and around Kiyamgei area of Imphal East District with a view to commit prejudicial activities. Based on the information and with the permission of the authority, a team of CDO-IW led by Inspector Gunachandra Chanam, OC-CDO-IW and myself under the command of Shri P. Achouba Meetei, MPS, Dy. SP (CDO), IW and under the supervision of Shri. N. Suraj Singh, MPS, Addl. SP(Ops.)/IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area after giving prior information to Imphal East District Police Control Room and conducted search operation at Kiyamgei Maning Leikai area. During that one suspected person was detained at Kiyamgei Maning Leikai. On spot verification, the detainee identified himself as Thokchom Jotilal Singh (29 yrs.) @ Angamba S/o. Th. Chinglen Singh of Kiyamgei Maning Leikai, Imphal East District, Manipur.

During preliminary verification, he disclosed that he is an active cadre of PREPAK organization and joined the said organization in August, 2024 through one Nanao of PREPAK organization and got Basic Military Training for 45 days in Kakching Khunou area and was allotted Army No. 76 (55th Batch). He also disclosed that he worked under the command of one s/s Commander Mangal of PREPAK organization from Kakching Khunou area.

Hence, he was arrested from the spot i.e., from Kiyamgei Maning Leikai at 03:18 pm by observing formalities.

And from his possession, one OPPO A83 mobile handset along with one Jio SIM card bearing mobile no. 6009951978 (as disclosed by him) was seized at the spot at 03:23 pm by observing due formalities

Hence, the arrested person and the seized article are handed over to you for taking further necessary legal action against him.
