12. **First Information Contents.** One Akoijam Tennyson Singh, ASI of CDO-IW lodge a written report to OC HNG-PS stating that on 20/11/2025 at about 04:25 pm, a reliable information was received from their own source and further corroborated from the information input provided by 31 AR regarding the presence of some active cadres of PREPAK organization, an outlawed banned organization, in and around Luwangsangbam area of Imphal East District with a view to commit prejudicial activities. Based on the information and with the permission of the authority, a team of CDO-IW led by Inspector Gunachandra Chanam, OC-CDO-IW and my complainant under the command of Shri P. Achouba Meitei, MPS, Dy. SP (CDO), IW and under the supervision of Shri. N. Suraj Singh, MPS, Addl. SP(Ops.)/IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area after giving prior information to Imphal East District Police Control Room and conducted search operation at Luwangsangbam area. During that one suspected person was detained at a rented house located at Luwangsangbam opposite to Liberal College. During spot verification, the detainee identified himself as Laishram Kiran Meitei (36 yrs.) @ Kirankumar @ Romen @ Angamba S/o. L. Nganba Meitei of Moirangkunou Makha Leikai, Bishnupur District, Manipur a/p at a rented house located at Luwangsangbam opposite to Liberal College, Imphal East District, Manipur (who later identified himself as the tenant of the said rented house). During preliminary verification, he disclosed that he is an active cadre of PREPAK organization and joined the said organization in the year 2008 and got Basic Military Training for 45 days in Keibul Lamjao area and was allotted Army no. 290757 (29th Batch) and he is presently holding the rank of s/s Lance Corporal of PREPAK organization. He also disclosed that he worked under the command of one s/s 2nd Lieutenant Prem @ Dhananjay of PREPAK organization from Laphupat Tera area (who is presently staying in Bishnupur area). He further disclosed that under the instruction of the above-mentioned s/s 2nd Lieutenant Prem @ Dhananjay, he was involved in extortion activities by serving monetary demands/threats to general public in valley area for raising their party fund. Hence, he was arrested from the spot i.e., at a rented house located at Luwangsangbam opposite to Liberal College at 06:34 pm by observing formalities. Further, from his possession, (i) one realme 13+ 5G mobile handset along with one Airtel SIM card bearing mobile no. 7628977878 (as disclosed by him), (ii) one CELLECOR X4+ mobile handset along with one Airtel SIM card bearing mobile no. 8413851180 (as disclosed by him) and (iii) one Aadhaar card bearing no. 6272 0143 8418 were seized at the spot at 06:40 pm by observing due formalities. Hence the case.
