Brief: On 27/11/2025 complainant namely ASI Khundongbam Bidyananda Singh, CDO Imphal West lodged a written report to OC/HNG-PS stating that today i.e. 27/11/2025 at about 03:20 am, a reliable information was received from their own source and further corroborated from the information input provided by 33 AR and 31 AR regarding the presence of some miscreants who are involved in concealing illegal arms and ammunitions in and around Kontha Ahallup area of Imphal East District with a view to commit prejudicial activities. Based on the information and with the permission of the authority, a team of CDO-IW led by Inspector Gunachandra Chanam, OC-CDO-IW assisted by ASI. Ak. Tennyson Singh of CDO-IW and myself under the command of Shri P. Achouba Meetei, MPS, Dy. SP (CDO), IW and under the supervision of Shri. N. Suraj Singh, MPS, Addl. SP(Ops.)/IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area after giving prior information to Imphal East District Police Control Room and conducted search operation at some suspected houses located at Kontha Ahallup Makha Leikai area. During that one suspected person was detained at a house located at Kontha Ahallup Makha Leikai, Imphal East District, Manipur. During spot verification, the detainee identified himself as Yumnam Chandra Singh (42 yrs.) @ Baby s/o Y. Manglem Singh of Kontha Ahallup Makha Leikai, Imphal East District, Manipur (who later identified himself as the resident of the said house). During preliminary verification, he disclosed that he was involved in the incident of snatching/looting of arms and ammunitions from the Kote of 7MR by over-powering the security personnel by a large mob in the year 2023 and he is still concealing 2 (two) nos. of hand grenades in his house for the purpose of committing prejudicial activities. As pointed out by him, one plastic container containing two nos. of No.36 HE grenade without detonator and one arming ring were recovered from the roof of the toilet located at the backyard of his house. Hence, he was arrested from the spot i.e., from his residence at 05:02 am by observing formalities. Further, from his possession, (i) the above mentioned plastic container containing two nos. of No.36 HE grenade without detonator and one arming ring, (ii) one Redmi 10 mobile handset along with one Airtel SIM card bearing mobile no. 8014575699 (as disclosed by him) and (iii) one Aadhaar card bearing no. 2866 0337 8756 were seized at the spot at 05:08 am by observing due formalities. Hence the case.
