Kameih of Nungbam Village (ii) Mr. Mizekpou Gangmei (61) yrs s/o (L) Tanangpou of Nungba Village (iii) Mr. Chingkhiugai Gonmei (50) yrs s/o Gonhang Gonmei of Nungba Village & (iv) Mr. Alung Kamei (66) yrs s/o Mathiuchung Kamei of Nungba Village to SP-IE stating that the learned Judicial Magistrate, Phailaladian was pleased to pass an order date 16/01/2023 in Cril Misc (Invt)/case No. 1 of 2023, directing the Officer in Charge Heingang Police Station, to conducted an investigation under section 156(3) Cr. P.C. The said order was issued after considering the complaint alleging that on 06/04/2022 the accused persons forged and fabricated a " special power Attorney" at an unknown rented room at ADC Bhawan, Sangakpham, Imphal, East, without the consent of 257 affected landowner, including the complainant to fraudulently withdraw compensation related to the NH-37 (Double lane) road expansion project. Hence the case.

Misc (Inv) Case No. 1 of 2023 passed by the court of Chief Judicial Magistrate, Imphal East, Manipur forwarded for investigation under Section 156(3) CrPC (Enclosed copy)

Sir,

With due respect, the undersigned beg to submit this representation for your kind attention and necessary action.

That, in connection with a complaint filed by Shri Thuiliang Kamei and three others against Shri Kadigaipou Kamei and two others, the Learned Judicial Magistrate, Phailaladian, was pleased to pass an order dated 16-01-2023 in Cril. Misc (Inv)/Case No. 1 of 2023, directing the Officer-in-Charge, Heingang Police Station, to conduct an investigation under Section 156(3) CrPC.

The said order was issued after considering the complaint alleging that on 06/04/2022, the accused persons forged and fabricated a "Special Power of Attorney" at an unknown rented room at ADC Bhavan, Sangakpham, Imphal East, without the consent of 257 affected landowners, including the complaint, to fraudulently withdraw compensation related to the NH-2 (Double Lane) road expansion project.

It was further stated before the Hon'ble Court that the complainants had earlier approached the Officer-in-Charge, Heingang Police Station, and the Superintendent of Police, Imphal East District, under Section 154(1) & 154(3) CrPC, but no action had been taken, compelling them to seek judicial intervention.

The Hon'ble Court after perusal of the materials on record and the supporting affidavit, found sufficient grounds and forwarded the case to the Officer-in-Charge, Heingang Police Station, for investigation.

In light of the above, the undersigned most respectfully request your kind office to:

1. Direct the Officer-in-Charge, Heingang Police Station; to initiate the investigation as directed by the Learned Magistrate vide order dated 16-01-2023 in Cril. Misc(Inv)/Case No. 1 of 2023.
2. Direct submission of an action-taken report (ATR) to your office and to the complainants concerned, as per law.

Your kind intervention in ensuring accountability and transparency in this matter will be highly appreciated.
