I have the honour to state that today i.e. 15/05/2025 at about 09:50am, a reliable information was received regarding the presence of some active cadres of SOREPA organization (a faction of KYKL organization) in and around Khonghampat area of Imphal West District to commit prejudicial activities like extortion of money from the general public and shops etc. Based on the information, a combined team of a column of 2/8 GR (Indian Army) and a team of CDO-IW led by Inspector Gunachandra Chanam, OC-CDO-IW assisted by Subedar Ch. Surjit Kumar and myself under the command of Shri P. Achouba Meetei, Dy. SP(CDO)IW and under the supervision of Shri Gaurav Dogra, IPS, i/c Addl. SP(Ops.)/IW and under the overall supervision of Shri Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area and conducted search operation at Khonghampat Awang Leikai area. During that one suspected person was detained for spot verification and checking at Khonghampat Awang Leikai near Koubru Laikon, Imphal West District. On spot verification, he identified himself as Shagolsem Leishemba Singh (22 yrs.) @ Pureiromba S/o. S. Abel Singh of Andro Loupaochum, Imphal East District.

During preliminary verification, he disclosed that he is an active member of SOREPA organization (a faction of KYKL organization) and he joined the said organisation in July, 2024 through one s/s Commander Hemanta of SOREPA organization and got Basic Military Training



for 30 days at Wangoo area and he is presently working under the command of the above mentioned s/s Commander Hemanta of SOREPA organization.

Hence, he was arrested from the spot i.e., Khonghampat Awang Leikai near Koubru Laikon, Imphal West District at 10:53am by observing necessary formalities.

From his possession, (i) one realme 53 NARZO mobile handset along with one Airtel SIM card bearing mobile no. 8132902572 (as disclosed by him) and (ii) one Aadhaar card bearing no. 8540 4214 9291 were seized at the spot at 11:01 am by observing due formalities.
