

With due respect, I have to state a few lines that today i.e. 7/01/2026 following the death of one drug user namely Late Shangkhil Sheltlung (26) yrs S/o Shangkhil Angdon of Angbrasu village, Chandel District in which a UD (Unnatural Death) case was taken up under vide UD case No.1/CDL-PS/26 Dated 07/01/2025. On the same day, as disclosed by the accomplice of the deceased I called up one Ms. Mate Zou (34) yrs. D/o Khamsuanmang of S. Mualnuam village, Chakpikarong Sub-Division, Chandel District, Manipur who is currently staying at a rented house located at Chandel Khullen through mobile phone and directed her to appear before me at Chandel police station. Accordingly, at around 4:00 pm of the day, Ms. Mate Zou showed up at Chandel Police Station and in that the Women Police checked her body and belongings. Later, on checking her belongings, I found one fake Aadhar card in the name of Mate Anal, some photographs of her clicked with suspected to be Heroin powder in her mobile phone. On preliminary interrogation of the said person, she disclosed that she is a regular drug peddler and has been continuing the same for last 2 years.

So, I request you to kindly take up further necessary legal action against her according to the law.


