Subject: Report

Sir,

I have the honour to state that today i.e. 04/12/2025 at about 12:35 pm, a reliable information was received from our own source and further corroborated from the information input provided by 33 AR regarding the presence of some active cadres of PREPAK (Pro) organization (a faction of PREPAK organization), an outlawed banned organization, in and around Thangal Bazar area of Imphal West District with a view to commit prejudicial activities. Based on the information and with the permission of the authority, a team of CDO-IW led by Inspector Gunachandra Chanam, OC-CDO-IW and myself under the command of Shri P. Achouba Meetei, MPS, Dy. SP (CDO), IW and under the supervision of Shri. N. Suraj Singh, MPS, Addl. SP(Ops.)/IW and under the overall supervision of Shri Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area and conducted search operation at some places of Thangal Bazar area. During that one suspected person was detained at Thangal Bazar near Majorkhul Gate. During spot verification, the detainee identified himself as Keisham Chingkhunba Singh (25 yrs) s/o (L) K. Ingobi Singh of Yairipok Bishnunaha, Thoubal District, Manipur a/p at a rented house located at Mahabali, Imphal East District, Manipur.

During preliminary verification, he disclosed that he is an active member of PREPAK (Pro) organization (a faction of PREPAK organization) and started working for the said organization since September, 2025 through one Veekash of PREPAK (Pro) organization from Palace Compound area who is presently staying in Myanmar. He also disclosed that he is presently working under the command of the above mentioned Veekash of PREPAK (Pro) organization as his s/s Commander. He further disclosed that under the instruction of his commander Veekash, he was involved in recruitment of youths for joining their party in valley area.

Hence, he was arrested from the spot i.e., Thangal Bazar near Majorkhul Gate at 02:28 pm by observing formalities.

Further, from his possession, (i) one Redmi Note 14 5G mobile handset along with two Jio SIM cards bearing mobile nos. (a) 6009635729 and (b) 9366784475 (as disclosed by him), (ii) one Aadhaar card bearing no. 9129 0207 1828 and (iii) a sum of Rs 400/- (Rupees four hundred only) were seized at the spot at 02:34 pm by observing due formalities.

Hence, the arrested person and the seized articles are handed over to you for taking further necessary legal action against him
