Subject: Lodging of FIR

Sir,

Ops – At 1445 hrs on 16 Dec 25, based on specific int. a Joint search Ops was carried out by combined team of COB Salluk ex 43AR and Chakpikarong PS from Toupokpi village to Singtam village. At about 1550 hrs. while conducting the search ops along the highway, a suspected item was found under the Culvert 1.5 Km ahead of Toupokpi village and 200 mtr Short of Singtam village. On inspection of the suspected item an unassembled IED along with 9 mm pistol and 09x live rds was recovered. The details of recovered items are as under.

- a) One iron container 150 gm approx.,
  - b) One waterproof plastic cover-150 gms approx
  - c) One gas gun amn -150 grms approx.,
  - d) One tear smk shell – 150 grms approx.,
  - e) One multi Batton cartridgege- 150 grms approx.
  - f) One Japanese made battery 6.90 v – 500grms approx.,
  - g) Expl. Approx 500 gms,
  - h) One country made pistol with mag.,
  - j) Live amn 9 rds., i) Two in wire black & red approx. 2 ft each,
  - k) Electric detonator no. 33-2 nos.
