FIRST INFORMATION REPORT

1. Based on specific input received from own sources regarding illegal transportation of Myanmar (WIN) Cigarettes, a Mobile Vehicle Check Post was launched at 1100 hours on 16 December 2025 by a party of 43 Assam Rifles in Gen Area Teijang Crossing, Chandel District.

2 During the mobile veh check post three loaded goods vehicles were intercepted at 1245 h. On detailed search of the vehicles, 199 Cartons of VWIN Cigarettes were recovered.

3. Details of Recovery

3.1 199 Cartons of WIN Cigarettes(each carton has 50 small cartons with 10 Packs each) and one carton of WIN Cigarettes with 46 small cartons with 10 packs each.

4. On further investigation it was revealed that the cigarettes were illegally transported from Khampat(Myanmar) to India through Border Pillar 50 in Churchandpur.

5. It is requested to investigate the matter and take necessary legal actions at your end.
