Subject: FIR on armed intimidation of Sinakeithei Passenger Bus by Kuki Militants at Molnom village.

Respected Sir,

We, the Sinakeithei village authority, on behalf of the citizens of Sinakeithei, wish to lodge this FIR regarding an incident that occurred on 8<sup>th</sup> September 2025 at around 7:30 a.m. – 8:30 a.m. The Sinakeithei Passenger bus was forcibly stopped at Molnom village by Kuki armed militants.

They brandished weapons, fired shots and threatened passengers, causing extreme fear and panic. The militants accused a passenger of recording videos, forcibly checked mobiles phone and warned everyone not to report the incident. Shockingly, they themselves recorded videos and uploaded them on their facebook page "ZOKHAN KHAUL".

This is not an isolated incident but part of repeated militant intimidation around our area. It also constitutes a serious violation of the Suspension of Operation (SoO) Agreement, recently extended on 4<sup>th</sup> September 2025.

We request your immediate action to:

1. Register this FIR and initiate a thorough investigation.
2. Take strict legal action against the militants involved.
3. Provide security and protection for Sinakeithei commuters and civilians.
4. Prevent recurrence of such unlawful militants activities.



