Surjit Kumar of CDO-IW and myself under the command of Shri. P. Achouba Meetei, MPS, Dy.SP(CDO)IW and under the supervision of Shri. Gaurav Dogra, IPS, i/c Addl. SP(Ops.)/IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area and conducted search operation at Kanglatongbi Bazar Board area. During that one suspected person was detained from a house located at Kanglatongbi Bazar Board, Imphal West District. On spot verification, the detainee identified himself as Warepam Shanta Singh (42 yrs) @ Tondon S/o W. Sakhitomba Singh of Kanglatongbi Bazar Board, Imphal West District (who later disclosed himself as a resident of the said house).

From his possession, one Redmi 10A mobile handset along with one Airtel SIM card bearing mobile no. 8413969004 (as disclosed by him) was recovered.

On preliminary verification, he disclosed that he kept concealed one black polythene bag containing a Pistol in the backyard of his house. As pointed out by him, one black polythene bag containing one 9mm Pistol marked with "07215" along with one magazine and 6 (six) rounds of

9mm ammunition was recovered at his instance which was found kept concealed in the backyard of his house.

Hence, he was arrested from his residence at 07:26pm for illegal possession of arms and ammunitions and the above the above recovered articles were seized at the spot at 07:34 pm by observing necessary formalities.

Hence, the arrested person and the seized articles are handed over to you for taking further necessary legal action against him.
