I am to state that today i.e. 11/07/2025 at 11:00 am a specific input received from 16<sup>th</sup> Assam Rifle regarding presence of some suspected valley base UGs group at the Maharabi under the Sekmai PS, on receiving the information teams of Special CDO, Unit Khabeisoi, led by Subedar L. Bebekananda Singh OC-SPL/CDO, including myself, assisted by Jem. L. Kuber Singh under the overall guidance of Dr. S. Ibomcha Singh, MPS, C.O. 6<sup>th</sup> IRB, In-Charge Special CDO unit, Khabeisoi rushed to the said area and started frisking checking in the area.

During the frisking and checking at about 11:30 am while the joint teams of 16<sup>th</sup> AR and Special commando teams 1(one) unknown person was observed approaching on foot from Maharabi near oil pump towards Imphal in a highly suspicious manner. Due to his suspicious behavior, he was detained for verification. The detainee was identified himself as Mr. Chingakham Sanjoy Singh @ Eremba Singh age about 42 yrs S/O. Chingakham Damu Singh of Kadangban Part (ii) Awang Leikai, Manipur.

On checking the detainee the following items i.e, i) 1(one) money Bag, Black in colour ii) one Aadhaar Card, no. 725430107251 iii) one Pan Card iv) two hundred rupees and v) one small paper having his army no. 5410243 writing in and his party slogan are found from his back pant pocket. During further questioning, the individual disclosed that he is an active cadre of the banned organization PREPAK (Red Army). He revealed that he joined the outfit on 15th March 2024

through one Mr. Thoudam Bisharup of Senjam Chirang Awang Leikai, and subsequently underwent 45 days of basic military training at Sangkai Training Centre, Myanmar, 185th training batch and army Number is 5410243. He further disclosed that he was active work at Naga Council, near Lahong Village, Myanmar, some about a total number of 60 cadres comprising 16 from PREPAK (Red Army) and 44 from NSCN-K are currently stationed. The said camp is under the command of 2nd Lieutenant Mr. Pakis of Keirang, Imphal East District. Further, he also revealed that the group possesses the following arms kept:- i) 2 (two) HK rifles, ii) 1 (one) AK rifle iii) 1 (one) pistol at the said Camp.

So, from the above facts and circumstances he was arrested at the Maharabi near Oil pump, Sekmai at 11:51 am and the above items were seized at 11:55 am.

The arrested person and seized items are handed over to you for further necessary legal action against him.
