Surjit Kumar and myself under the command of Shri. P. Achouba Meitei, MPS, Dy.SP(CDO)IW and under the supervision of Shri. Gaurav Dogra, IPS, i/c Addl. SP(Ops.)/IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area and conducted search operation at Maharabi area. During that one suspected person was detained at Maharabi near Oil Pump. On spot verification, the detainee identified himself as Sanabam Ibungo Meitei (27 yrs) @ Langamba S/o. S. Premjit Meitei of Yairipok Top Chingtha Maibam Leirak, Imphal East District.

During preliminary verification, he disclosed that he is an active member of KCP (PWG) organization (a faction of KCP organization) and started working for the said organization since January, 2025 and presently working under the command of one s/s Commander Raj Khuman (Ph. No. 9365031488) of KCP (PWG) organization from Moirang area. He further disclosed that under

Further, he also disclosed that today on 23.07.2025, as instructed by Commander Raj Khuman, he served monetary demands/threats to oil pumps located in Sekmai and Maharabi areas.

Hence, he was arrested from the spot i.e., at Maharabi near Oil Pump at 01:34 pm after observing necessary formalities.

From his possession (i) one iPhone 11 mobile handset along with one Airtel SIM card bearing mobile no. 8414811642 (as disclosed by him), (ii) one brown wallet containing a sum of Rs. 2000/- (Rupees two thousand only) and one Aadhaar card bearing no. 3305 7017 3736 and (iii) several demand notes marked with "KANGLEIPAK COMMUNIST PARTY PEOPLE'S WING G.M.P +918731904782 Punsiba Moirang the Mobile Team" were seized at the spot at 01:34 pm after observing due formalities.

From his possession (i) one iPhone 11 mobile handset along with one Airtel SIM card bearing mobile no. 8414811642 (as disclosed by him), (ii) one brown wallet containing a sum of Rs. 200 - (Rupees two thousand only) and one Aadhaar card bearing no. 3305 7017 3736 and (iii) seven nos. of demand notes marked with "KANGLEIPAK COMMUNIST PARTY PEOPLE'S WAR GROUP +918731904782 Punsiba Moirangha Mobile Team" were seized at the spot at 01:41 pm by observing due formalities.

Hence, the arrested person and the seized articles are handed over to you for taking further necessary legal action against him.
