12. First Information contents:

I have the honour to state that, today, i.e. 4th November, 2025 at around 04:00 am, received reliable intelligent from a source that, a huge consignment of illegal drugs is going to transact or sell at LNC & Sons filling Station, Sekmai Pangaltabi by some unknown person. Accordingly, I recorded the input into writing and a copy of the same is forwarded to SP-IW for necessary action. However, I could not obtained search authorisation as there was high chances of escape of accused person and concealment of the drugs.

Immediately, self along with my police team and a team of Sekmai PS rushed at the said area. On reaching there, two suspected person with a polythene bag of multiple colour were found in a suspicious manner. In that, they were stopped for verification. As no willing independence witnesses were available I called two police personnel of my escort to be witnesses while conducting legal procedure. On verification in presence of witnesses, they identified themselves as i) Md. Mustakim (28) S/o (L) Md. Salaoddin of Lilong Lou Manga and ii) Umar Khan (30) S/o (L) Abdul Sattar of Lilong Chingkhram Maning. On suspicion of possessing contraband drug inside the polythene carry bag of Md. Mustakim (28) S/o (L) Md. Salaoddin of Lilong Lou Manga, I informed a gazetted officer viz SDPO - Lamphel through the police team of Sekmai PS to be present during the search and seizure process. Requisition also sent to Mobile FSL, Imphal West team to be present during the seizure process.

At around 07:00 am, Shri Rescue Shimray, MPS, SDPO Lamphel and a team of Mobile FSL/IW Unit arrived at the spot. Then, in present of witnesses and SDPO Lamphel, the polythene bag possessed by Md. Mustakim (28) S/o (L) Md. Salaoddin of Lilong Lou Manga was checked. On

checking the bag, four transparent plastic packet containing suspected to be Heroin powder (brown Sugar) were found concealed at the bottom of the bag covered by clothes and biscuits. The plastic packet containing Heroin powder (brown sugars) was marked as A1, A2, A3 and A4. Then, on testing by the forensic team, it gave positive result to Heroin.

On weighing, A1, A2, A3 and A4 weighed 0.521 kgs, 0.485 kgs, 0.512 kg and A4 0.508 kgs i.e. altogether Kgs. 02.026 kgs including the weighed of plastic packets. Thereafter, A1, A2, A3 and A4 were put inside four different yellow paper envelopes and marked as A, B, C and D respectively which was properly packed and sealed by using wax.

Accordingly, the following items viz (i) envelope marked as A, B, C and D containing exhibits (Heroin powder) A1, A2, A3 and A4 (ii) one REDMI mobile handset having mobile number 8119900906 and (iii) a sum of Rs. 4120/- in cash were seized from the possession of Md. Mustakim (28) S/o (L) Md. Salaouddin of Lilong Lou Manga at 8:42 am of the day in presence of witnesses after observing all due formalities. Subsequently, Md. Mustakim (28) S/o (L) Md. Salaouddin of Lilong Lou Manga was arrested at 8:50 am. Further, his associate namely, Umar Khan (30) S/o (L) Abdul Sattar of Lilong Chingkhram Maning was also arrested at 8:55 am of the day.
