Shivanand Surve, IPS, Superintendent of Police Imphal East District at 3:30 p.m. after providing prior information to Imphal West District police.

In that, one suspected car was detained for spot verification and checking at Awang Wabagai Lamkhai, near Keystone Infra Pvt. Ltd. (KIPL) Office, Sekmai PS, Imphal West. On checking the

driver of the car, two nos. mobile phones, one sling bag and one wallet containing a sum of Rs. 1200/- (one thousand two hundred) rupees and one AADHAAR card were found and recovered. On verification he (driver) identified himself as one Konthoujam Nelson Singh @ Thomba (23 years) S/o K. Nabadip Singh of Lambal Sabal Leikai, Lamshang PS, Imphal West District. On checking the occupants of the car, two nos. of mobile phones and one wallet containing a sum of Rs. 220/- (two hundred and twenty rupees) and one AADHAR card were found and recovered from his possession. On verification, he identified himself as one Ningthoujam Nongpoknganba Meitei (31 years) S/o (Late) Ng. They further stated that, today they came to collect extortion money from a person at Awang Wabagai area on the instruction and command of the said Mr. Liklangamba of UNLF (Pambei) group. On further examination, they further stated that they were directly involved in extortion of money from Govt. offices and private firms for raising their party fund on the command of the said Mr. Liklangamba of UNLF (Pambei) group.

So, both the detainees, Konthoujam Nelson Singh (Driver) and Ninthoujam Nongpoknganba Meitei (occupant), were arrested from the spot i.e. Awang Wabagai Lamkhai, near Keystone Infra Pvt. Ltd. (KIPL) Office, Sekmai PS, Imphal West at 4:08 p.m. and 4:11 p.m. respectively by observing due formalities. 
