I have the honour to state that, today i.e. 18<sup>th</sup> Dec, 2025 at about 3:30 PM, reliable information was received regarding the hijacking of a truck bearing Registration no. NL 07

AA/6411 carrying 250 boxes of iced fish at around 1:30 PM on the Maharabi-Pheidinga stretch by some unknown miscreants, who came on a Scorpio vehicle and took it towards the Senjam Chirang-Phumlou side.

Relying on the information, a strong team of Imphal West Police led by Shri P. Achouba Meitei, DSP/CDO/IW comprising of OC/Sekmai PS, OC/CDÖ-IW, CDO In-Charge Sekmai Unit, a team of Lamsang PS and a team of F-120 CRPF under the command of Shri N. Suraj Singh, MPS/Addl-SP(Ops)-IW and overall supervision of Shri Ksh. Shivakanta, IPS/SP-IW, rushed from three different directions and conducted a search operation at Senjam Chirang and Lamsang area.

While conducting frisking and checking at Senjam Khunou near Mahajon corner, my team saw the hijacked Truck bearing Registration No. NL07AA-6411 coming towards Khurkhul from Phumlou side at around 04:20 pm and was detained. On spot verification, the driver of the truck identified himself as Md. Salman Khan (35 years), S/o (L) Md. Sana, resident of Yairipok Tulihal, Imphal East District and also an active member of UNLF(P). On questioning him, it came to know that, half of the iced fish from the hijacked truck were shifted to two different Tata Tipper Hydra Dumper trucks and went towards Lamsang side. Immediately, information had been shared to all other team who are on rescue operation. Subsequently, Md. Salman Khan (35 years), S/o (L) Md. Sana, resident of Yairipok Tulihal was arrested at 04:30 pm of the day with the seizure of 1) One Tata truck bear registration No.NL07AA-6411 2) 110 nos. of boxes containing ice fish 3) One mobile handset REDMI 5G having SIM Card bearing mobile no.8787735256(JIO) at 4:48 pm from his possession. On further searching inside the vehicle, found on Road Challan in the name "STAR FISH" of 250 boxes and seized the same on 4:55 pm.

~~In the meantime, received information that, two Tata Tipper Hydra Dumper trucks bearing~~ Registration No. NIL and MN03/1899 loaded with iced fish were detected by a combined team of CDO IW and Lamshang PS at Lamsang near Himalaya Tiles gate at @ 5:00 pm of the day along with three active member of UNLF (P) and two drivers and one second driver. Then, my team along with arrested person rushed towards the said area. While the detected Truck bearing Registration No. NL07AA-6411 had been sent to Sekmai PS along with a team of Sekmai PS.

Upon arrival at Lamsang near Himalaya Tiles gate and verifying the spot, the driver of the Tata Tipper Hydra Dumper bearing regn No. Nill identified himself as Waikhom Bijen Meitei(31)yrs s/o Late W. Budha Meitei of Yairipok Nungaipokpi Mamang Leikai, Imphal East and 2<sup>nd</sup> driver(handy man) identified himself as Loukrakpam Shitaljit Singh(32)yrs s/o Late L. Ningthem Singh of Yairipok Nungaipokpi Mamang Leikai, Imphal East. The driver of the tata Tipper Hydra Dumper bearing Regn No. MN03/1899 identified himself as Pukhrambam Mahesh Singh(23)yrs s/o P. Amu Singh of Torbung Bangla, Bishnupur District. On further verification of three unknown person in the two tata Tipper Hydra Dumper who came along with the two drivers and one 2<sup>nd</sup> driver(handy man), they identified themselves as (i) Bonish Sagolsem (25 years), S/o

Shri Binodkumar Meetei, resident of Yairipok Laimanai, Imphal East District (ii) Herojit Sharma (32 years), S/o (L) Sanatomba Sharma, resident of Yairipok Bishnunaha Mayai Leikai, Thoubal District and (iii) Asem Amar Meitei (20 years), S/o A. Joy Meitei, resident of Wangoo Sabal Awang Leikai, Bishnupur District. On spot questioning, they admitted that they are active members of the UNLF (P) and involved in the hijacking of the Tata truck loaded with iced fishes

from Maharabi-Pheidinga stretch. They also disclosed that the detected iced fishes from the two Tata Tipper Hydra Dumper trucks was from the hijacked Tata truck and they shifted it somewhere at Phumlou Pukhri Mapal.

Accordingly, 1) Waikhom Bijen Meitei(31)yrs s/o Late W. Budha Meitei of Yairipok Nungaipokpi Mamang Leikai, Imphal East(driver of Tata Tipper Hydra Dumper bearing regn No. Nil)was arrested on 5:25 pm. From his possession seized on "SAMSUNG A14 5G having SIM Card bearing mobile no 8119940659(JIO) on 5:28 pm of the day.

2) Loukrakpam Shitaljit Singh(32)yrs s/o Late L. Ningthem Singh of Yairipok Nungaipokpi Mamang Leikai, Imphal East(handy man of Tata Tipper Hydra Dumper bearing regn No. Nil )was arrested on 5:32 pm .From his possession seized "REDMI NOTE 8" blue in colour having SIM Card bearing mobile no 9362008997(AIRTEL) on 5:37pm of the day.

3) Pukhrambam Mahesh Singh(23)yrs s/o P. Amu Singh of Torbung Bangla, Bishnupur District(driver of the tata Tipper Hydra Dumper bearing Regn No. MN03/1899) was arrested on 5:42 pm. From his possession seized "REDMI 9A" having SIM Card bearing mobile no 8413063585(AIRTEL) on 5:47pm of the day.

4) Bonish Sagolsem (25 years), S/o Shri Binodkumar Meetei, resident of Yairipok Laimanai, Imphal East District was arrested on 5:52pm. From his possession seized one tata Tipper Hydra Dumper bearing Regn No. MN03/1899, 71 boxes containing iced fish, one mobile handset "REDMI 5G" black in colour having SIM Card bearing mobile no 7005317180(AIRTEL) and one Aadhar Card on 6:20pm of the day.

5) Shamulailatpam Herojit Sharma (32 years), S/o (L) Sanatomba Sharma, resident of Yairipok Bishnunaha Mayai Leikai, Thoubal District was arrested on 6:25 pm. From his possession seized one Tata Tipper Hydra Dumper bearing regn No. Nill, 69 boxes containing iced fish, one mobile handset "SAMSUNG A55" having SIM Card bearing mobile no 8787417326(JIO) white in colour, one mobile handset "SAMSUNG A56" grey in colour having SIM Card bearing mobile no 6009306046(JIO) on 6:50 pm of the day.

6) Asem Amar Meitei (20 years), S/o A. Joy Meitei, resident of Wangoo Sabal Awang Leikai, Bishnupur District was arrested on 6:55 pm. From his possession seized one mobile handset "REDMI 9PRO MAX" dark blue in colour having SIM Card bearing mobile no 9612850728(AIRTEL) and 9863925390(JIO) on 7:00 pm of the day.



Subject: Report regarding hijacking of a truck carrying fish and subsequent recovery and arrests.

Sir,

I have the honour to state that, today i.e 18<sup>th</sup> Dec, 2025 at about 3:30 PM, reliable information was received regarding the hijacking of a truck bearing Registration no. NL 07 AA/6411 carrying 250 boxes of iced fish at around 1:30 PM on the Maharabi-Pheidinga stretch by some unknown miscreants, who came on a Scorpio vehicle and took it towards the Senjam Chirang-Phumlou side.

Relying on the information, a strong team of Imphal West Police led by Shri P. Achouba Meitei, DSP/CDO/IW comprising of OC/Sekmai PS, OC/CDO-IW, CDO In-Charge Sekmai Unit, a team of Lamsang PS and a team of F-120 CRPF under the command of Shri N. Suraj Singh, MPS/Addl-SP(Ops)-IW and overall supervision of Shri Ksh. Shivakanta, IPS/SP-IW, rushed from three different directions and conducted a search operation at Senjam Chirang and Lamsang area.

While conducting frisking and checking at Senjam Khunou near Mahajon corner, my team saw the hijacked Truck bearing Registration No. NL07AA-6411 coming towards Khurkhul from Phumlou side at around 04:20 pm and was detained. On spot verification, the driver of the truck identified himself as Md. Salman Khan (35 years), S/o (L) Md. Sana, resident of Yairipok Tulihal was arrested at 04:30 pm of the day with the seizure of 1) One Tata truck bear registration No.NL07AA-6411 2) 110 nos. of boxes containing ice fish 3) One mobile handset REDMI 5G having SIM Card bearing mobile no.8787735256(JIO) at 4:48 pm from his possession. On further searching inside the vehicle, found on Road Challan in the name "STAR FISH" of 250 boxes and seized the same on 4:55 pm.

In the meantime, received information that, two Tata Tipper Hydra Dumper trucks bearing Registration No. NIL and MN03/1899 loaded with iced fish were detected by a combined team of CDO IW and Lamshang PS at Lamsang near Himalaya Tiles gate at @ 5:00 pm of the day along with three active member of UNLF (P) and two drivers and one second driver. Then, my team along with arrested person rushed towards the said area. While the detected Truck bearing Registration No. NL07AA-6411 had been sent to Sekmai PS along with a team of Sekmai PS.

Upon arrival at Lamsang near Himalaya Tiles gate and verifying the spot, the driver of the Tata Tipper Hydra Dumper bearing regn No. Nill identified himself as Waikhom Bijen Meitei(31)yrs s/o Late W. Budha Meitei of Yairipok Nungaipokpi Mamang Leikai, Imphal East and 2<sup>nd</sup> driver(handy man) identified himself as Loukrakpam Shitaljit Singh(32)yrs s/o Late L. Ningthem Singh of Yairipok Nungaipokpi Mamang Leikai, Imphal East. The driver of the tata Tipper Hydra Dumper bearing Regn No. MN03/1899 identified himself as Pukhrambam Mahesh Singh(23)yrs s/o P. Amu Singh of Torbung Bangla, Bishnupur District. On further verification of three unknown person in the two tata Tipper Hydra Dumper who came along with the two drivers and one 2<sup>nd</sup> driver(handy man) ,they identified themselves as (i) Bonish Sagolsem (25 years), S/o

From his possession seized on "SAMSUNG A14 5G having SIM Card bearing mobile no 8119940659(JIO) on 5:28 pm of the day

2) Loukrakpam Shitaljit Singh (32 yrs) s/o Late L. Ningthem Singh of Yairipok Nungaipokpi Mamang Leikai, Imphal East (handy man of Tata Tipper Hydra Dumper bearing regn No. Nill) was arrested on 5:32 pm. From his possession seized "REDMI NOTE 8" blue in colour having SIM Card bearing mobile no 9362008997(AIRTEL) on 5:37 pm of the day.

3) Pukhrambam Mahesh Singh (23 yrs) s/o P. Amu Singh of Torbung Bangla, Bishnupur District (driver of the tata Tipper Hydra Dumper bearing Regn No. MN03/1899) was arrested on 5:42 pm. From his possession seized "REDMI 9A" having SIM Card bearing mobile no 8413063585(AIRTEL) on 5:47 pm of the day.

4) Bonish Sagolsem (25 years), S/o Shri Binodkumar Meetei, resident of Yairipok Laimanai, Imphal East District was arrested on 5:52 pm. From his possession seized one tata Tipper Hydra Dumper bearing Regn No. MN03/1899, 71 boxes containing iced fish, one mobile handset "REDMI 5G" black in colour having SIM Card bearing mobile no 7005317180(AIRTEL) and one Aadhar Card on 6:20 pm of the day.

5) Shamulailatpam Herojit Sharma (32 years), S/o (L) Sanatomba Sharma, resident of Yairipok Bishnunaha Mayai Leikai, Thoubal District was arrested on 6:25 pm.
