11. First Information contents:

In continuation of 'War on Drug', a combined team comprising of Ukhrul District Police, 4<sup>th</sup> Mahar Regiment, B-Coy 57 Bn. BSF, D-Coy 79 Bn. BSF, Forest Department Ukhrul, NAB, NCB and Executive Magistrate LM-Block led by SDPO/JSM conducted destruction drive of illegal poppy plantation from 16/12/2025 to 18/12/2025 at Yaolen-Lamlai Chingphei hill ranges, Latitude - 24.988171°N and Longitude - 94.201573°E, under the supervision of Superintendent of Police, Ukhrul. During the poppy destruction drive, an area of about 48(forty-eight) acres on 16/12/2025, 85(eighty-five) acres on 17/12/2025, and 67(sixty-seven) acres on 18/12/2025 were destroyed. A total area of 200 (two hundred) acres of poppy plantation was destroyed which is expected to yield about 1800 (one thousand eight hundred) kg of opium (@9kg per acre). No cultivator was found in the field and no arrest was made during the destruction drive. Seized some poppy pods from the field for adducing evidence.

Hence, a regular case suo-motu under FIR No. 8(12)2025 LTN-PS U/S 18(b) ND & PS Act, has been registered for investigation.
