Subject:- Submission of report

Sir,

It is humbly submitted that on 27/12/2025 at 5.26 pm a complaint was received at Thoubal police Station from one Yumnam Nabachandra Singh of Thoubal Kiyam Siphai Khong Ahanbi alleging that on 25th, December, while listening TV news at night in his room, he received a call from an unknown number at 9.52 pm introduced himself as Priyananda threatening him with the following words that why he was involving in the MNCA's election in consultation with his brother-in-law Biju. He has party so he can do anything (implying killing, beating and torturing) upon him at anytime and anywhere. Stopped involving immediately. He (complainant) was nothing even though he was the UCM president. He (complainant) would never get votes in his Assembly election late. He used many bad words too including slang.

Most of the family members including minors were unable to sleep well by his terrible words. Being a politician as well as candidate of BJP in the last Manipur Legislative Assembly Election, 2022 from 32, Wangkhem AC, he has now a fear psychosis to live and move around in his Assembly Segment and also even in my locality.

Details of the offence are as follows:

Name of the person as he introduced by himself: Priyananda

Phone number from which threatening comes: +918787591099

Witness at the time of call: His wife, his 12 yrs old son and his two daughters of 10 yrs and 7 yrs old.

Hence an enquiry is conducted under GD entry No. 18/TBL-PS/2025 dated 27/12/2025.

During the enquiry, a requisition letter was sent to the Superintendent of Police, Thoubal Manipur for providing CAF of the mobile number 8787591099 (jio) to ascertain the identity of the alleged unknown accused. Further, on received of the CAF, the alleged accused is identified as one Singam Priyananda Singh (47) S/o S. Achou Singh of Singjamei Chingamakha Phuramakhong PO & PS Singjamei.

During the enquiry, the contents of the complaint disclose that the accused person intentionally threatened the complainant with serious consequences including implied threat to life and bodily harm. The threat was sufficient to cause alarm and fear in the mind of the complainant. The use of abusive language in front of his wife and children further indicates criminal intent.

On the basis of the complainant and enquiry conducted, a prima facie case is made out which is cognizable in nature.

It is therefore submitted the report for kind necessary action please.
