## 12. First Information contents:

Today i.e. 20/01/2026 at 07.40 pm received a reliable information that on the same day i.e. 20/01/2026 at around 07.35 pm a road traffic accident had occurred just near the entrance of the IVR of Khongjom – Chingtham, along the NH No. 102, between two vehicles which were one Honda Dio scooter, orange and grey in colour, without registration number, ridden by an unknown rider, plying from Khongjom Bazar side towards Wangjing side along NH-102, and one TVS Jupiter scooter, dark blue in colour, bearing Registration No. MN01AM-4059, ridden by an unknown rider, who had crossed the NH No. 102 so as to travel through the IVR of Khongjom–Chingtham, as the two vehicles collided each other due to rash or negligent ridding on the part of both the unknown riders of both the vehicle. As a result of the collision, the riders of both the vehicles sustained injuries on their persons and were evacuated to hospital for medical treatment. Further, one Jawan of 46 Assam Rifles, who was present at the spot performing his assigned duty, sustained a fracture injury on his left leg as being hit by the Honda Dio after the collision, so the injured Jawan was taken up by a team of 46 Assam Rifles for his medical treatment. The involved vehicles were also partly damaged.

Hence a suo-moto case under FIR No. 03(01)2026 KJM-PS, U/S-281/125(b)/324(4) of BNS 2023, has been registered for investigation.
