Subject: Complaint Regarding Criminal Intimidation,
Threat to Life, and Use of Abusive Language by Four
Persons

Respected Sir,

I, Mohammed Arshad Melhdi, son of Md. Nurul Islam, resident of Thoubal Moijing Lamkhai, Thoubal District, Manipur, do hereby lodge this complaint against three persons, namely Md. Shahnawaz S/o Banur Jaman, Md. Sohail S/o Shahnawaz, and Md. Raj Khan S/o Shahnawaz of Thoubal Moijing Lamkhai, Thoubal District, Manipur, for committing offences of criminal intimidation, threat to cause death or grievous hurt, and using abusive language intended to insult and provoke breach of peace. The incident occurred today, i.e., on 02nd January 2026, at around 9:30 AM, when my mother was passing before their gate towards the canal.

Details of the Incident: On the aforesaid date and time, my mother was proceeding towards the canal via the path in front of the gate of the accused persons. Without any provocation, the said three persons, issued life-threatening statements. Specifically, they threatened to kill her by shouting in Manipuri, "Thangna Yanthatlaga hatkadabani, thangdu puthorak u," which translates to "kill with sword, bring the sword." They further stated "jail da leirasu chahi amakhaktani" (which translates to "even if I get arrested, I will get punished for only 1 year jail"). This was a direct threat to her life, causing her immense fear and apprehension of immediate harm.

Furthermore, the accused persons used highly derogatory and abusive language against her, including words like "Kasubi" (meaning prostitute) and "thunapang gi nupi" (meaning wife of deaf). These words were uttered with the intent to insult her modesty, humiliate her, and provoke a breach of the peace. Additionally, they made arrogant remarks challenging the authority of the judiciary, stating words to the effect of "what the High Court can do in the present case as they have more power than the High Court."

This incident appears to be connected to an ongoing civil dispute regarding the demarcation of the IVR road from MI road to Ikoppat, which is currently pending before the Sub-Divisional Collector (SDC), Lilong, and the Revenue Tribunal, Thoubal. The accused persons seem to be escalating the matter through criminal means to intimidate my family.

The actions of the accused constitute the following offences under the Bharatiya Nyaya Sanhita (BNS), 2023:

- Section 351(2) and 351(3): Criminal intimidation by threatening to cause death or grievous hurt.
- Section 79: Word, gesture, or act intended to insult the modesty of a woman.
- Section 352: Intentional insult or provocation to any person, intending or knowing it to be likely that such provocation will cause him to break the public peace.

I request you to kindly register this complaint as a First Information Report (FIR) under the aforementioned sections of BNS, 2023, and any other applicable provisions. Please investigate the matter urgently, take necessary action against the accused persons, including their arrest if required, and ensure the safety of my mother and family members. I am ready to provide any further details, witnesses, or evidence as needed for the investigation.
