Sir,

I have the honour to report that today i.e 08/01/2026 at around 2.00 pm, while I visited the site of Reliance JIO Tower located at Waithou Ching (site ID: I-NE-THBL-ENB-6003) for routine checking, it is found that 3 (three) nos. of ODC Batteries of vision 100 AH were missing. It is suspected that some unknown persons were stolen away the said batteries during the intervening night of 7/01/2026 & 8/01/2026 by breaking down the ODC door. The approximate value of the said batteries is about Rs. 2,01,000/- (Rs. 67000X3) (two lakhs and one thousand) only.

It therefore, requested to kindly take up necessary legal action in this regard.
