First Information contents: Today i.e. 09/01/2026 at 5:40 pm, received information that on the same day at about 5:30 pm, a road mishap occurred at Wangbal opposite to Habron cafe along NH102 between two vehicles i.e. one Honda Dio b/regn. No. MN01F1246 ridden by unknown rider coming from Wangjing towards Thoubal and another one Tractor with tailor bearing registration No. not known driven by unknown driver coming on the same direction due to rash & negligent driving on the part of the unknown driver of Tractor and was fled away from the spot towards Thoubal side. As a result, the rider sustained injury and evacuated to District Hospital Thoubal for medical treatment. The H/Dio was also partly damaged.
