Farid Khan after declaration of the result situated at Lilong Haoreibi Darul Uloom Makha shouting "Farid na Vote kare-Farid na Vote Kare" (Farid won the vote). On reaching near

the gate of Md. Anish Khan S/O Md. Ashraf Ali who was defeated by my cousin brother in the contest, suddenly Md. Arif Khan S/o. Md. Ashraf Ali of Lilong Haoreibi Turel Ahanbi Buya Salam along with about 15(fifteen) unknown persons rushed towards our vehicles by holding sticks and smashed on the vehicle Creta bearing regd. No. MN06LX 1710 with hockey sticks and broke down glasses of the Creta car. Thereafter Md. Imran Khan S/O Md. Ashraf Ali of Lilong Haoreibi Turel Ahanbi Buya Salam and Md. Anish Khan S/O do along with their unknown associates started pelting stones towards our vehicles. In their action, our two vehicles i.e. Alto Lxi blue in colour regd. MN 06LX 0922 and Alto Lxi Maroon bearing no. MN 06LX 5959 got damaged. They didn't stop attacking us and on their continuous attack, Md. Sabir Ahamed of Lilong Haoreibi Lou Manga and Md. Azaruddin of Lilong Chingjao got injured on their persons. As they attacked us, we fled from the place bringing the injured persons on one Eeco Van bearing regd. No. MN01G/8636. However, on the way Md. Riyaj Khan S/O Md. Ahamed Ali of Lilong Haoreibi Turel Ahanbi Buya Salam and Md. Serajur Rahaman S/O Late Mohd. Obeidula of Lilong Haoreibi Turel Ahanbi Buya Salam attacked the Eeco Van and broke down the rear glass of the Eeco Van. Somehow we could manage to escape from the place.
