11. First Information contents: Today, i.e. 25/12/2025 at 10:55 pm, received an information that on the same day at about 10:50 pm, one vehicle Maruti Swift Car bearing regn. no. MN01AX0536 driven by an unknown driver proceeding from Wangjing towards Thoubal side along NH102 dashed on the back side of one Mahindra Scorpio bearing regn.no. MN01AK0815 which was also driven by an unknown driver and proceeding in the same direction at Khangabok Bazar along NH-102 due to rash or negligent driving on the part of both unknown drivers of both vehicles. As a result, the unknown driver of Maruti Swift Car bearing regn. no. MN01AX0536 sustained injury and evacuated to Hospital for Medical Treatment whereas the others not. During the incident the Maruti Swift car bearing regn. no. MN01AX0536 was badly damaged however the Mahindra Scorpio bearing regn.no. MN01AK0815 was partly damaged .Hence, the case.
