Sir,

I have the honour to report that today i.e. 29-12-2025 at around 10:20 am, my elder brother namely Thingujam Kumar Singh (55) yrs S/o Thingujam Iboton Singh of Thoubal Tangjeng Achouba along with his wife namely Thingujam Ongbi Subhasini Devi left their house after locking it properly to plant vegetables at their parcel of land which is used for farming located at Kiyam Wangmataba Awang Leikai. On the same day at around 11:30 am, the main door lock of their house was found broken when they returned after planting vegetables. On further checking inside their house, Rs. 4,00,000/- (rupees four lakhs) in cash and gold ornaments about 42 sans value about 12,60,000/- (rupees twelve lakhs sixty thousand) which was kept inside Iron godrej of my elder brother's bed room was found stolen away after the lock of iron godrej was broken by unknown person by taking the absence of family members.

It is, therefore, requested to kindly take up necessary legal action.
