Sir,

With due regards, I beg to state that today i.e. 30/12/2025 at about 04:00 a.m. received a reliable information that some unknown armed miscreants have stored and hidden some arms, ammunitions and explosives at the foot hill of Yerum Ching for using offensive act against State Security Forces and CAPF.

On receipt of the information, joint team of Commando Unit, Thoubal led by Shri. Harsavarthan V, IPS (Probation) and Inspt. K. Nitaranjan Singh, OC/CDO-TBL and under the overall supervision of Shri. Manoj Prabhakar M, IPS, Superintendent of Police, Thoubal and a column of 33 AR have rushed to the spot immediately and launched a massive operation at 05:40 a.m. On searching and found the undernoted articles i.e.

6. 25 (twenty five) Nos. of 7.62 x 39 mm (AK) ammunition,

8. 5 (five) Nos. of 7.62 x 51 mm (SLR) ammunition,
9. 1 (one) No. of .303 ammunition,
10. 4 (four) Nos. of detonator,
