Sir,

I have the honour to report that today i.e 28/12/2025 at about 10:40 am I along with my husband namely Moirangjam Amarjit Singh aged about 42 Years S/O Late Moirangjam Mangoljao Singh came to my home from Khwairamband Keithel by riding a Honda Activa by my husband. On reaching Wahengbam Leikai Road opposite Keishampat Thokchom Leikai one four-wheeler Tata Nexon bearing Regd. No MN01AG 0582 plying from the same direction stop in front of our vehicle after overtaking from our vehicle. We made a verbal argument between us as the driver of the Tata Nexon enquired against my husband that there is a slang language towards him. Then he drove from the spot at about 10/20 meters and finally stop his vehicle. After that he came and attacked towards my husband. My husband also tried to protect himself. In the meantime, the driver of the Nexon Car assaulted my husband by using knife or other dangerous weapon and thereby causing major injury in the lower parts of my husband. He is undergoing treatment at Raj Medicity North AOC Imphal. Doctor advised me to need major surgery. The acts done by him is tantamount for punishable under attempts to murder.

I, therefore request your good office to take necessary action against the culprit as per law at the earliest.
