Sub: - Report

Sir,

I am to report that today i.e. on 28/12/2025 at @ 11:15 am, while I along with my husband namely Thangjam Sukumar Singh (42) yrs S/o Late Th. Kunjaraj Singh of Keisampat Thokchom Leikai and our minor son aged about 10 yrs were returning back home in our four wheeler vehicle Tata Nexon along the road of Wahengbam Leikai towards Keishampat Junction. When we passed Kangabam Leikai area and reaching Keishampat Thokchom Leikai along Nambul river side, a couple riding a two-wheeler vehicle Honda Activa suddenly overtook our plying vehicle in a very rash manner that their vehicle nearly hit our vehicle. On that when my husband who was in panic shouted to watch out the rider halted his vehicle abruptly in front of our vehicle. The rider demanded husband to have a final word with him. We rushed out of our vehicle and there occurred a verbal argument between the rider and my husband. I somehow managed to calm my husband down but the honda Activa rider suddenly embraced me from behind by maneuvering me he strikes my husband's head with his helmet 4(four) times. I tried to pull him away, but he grabbed my right arm and pushed me away. My shirt was torn exposing the part of my flesh in a public place. Then he scuffled with my husband on the road and when my husband was lying flat, he strangled my husband with his left hand and punched multiple times over the face with his right fist. I was helpless and shouted for help. On the contrary the wife of the rider was capturing video of the whole scenario instead of trying to be stopping her husband. Luckily some local people from the opposite side intervened and stopped him. AS my husband got injured on his body and started vomiting, we immediately went to JN Hospital for treatment. Besides assaulting towards my husband, the acts done by him is tantamount for punishable for assaulting or using criminal force on a woman with the clear intention of insulting the women modesty.

Later on, we learnt the identity of the unknown rider as one Moirangjam Amarjit Singh aged about 41 yrs S/o (L) M. Mangoljao Singh of Keishamthong Maning Lonjam Leikai.

I therefore request you to kindly take appropriate legal action against him for use criminal force on a woman with the clear intention of insulting the women modesty.


