12. First Information contents:

That 12/11/2025 at about 06:00 am an operation was launched at Awlmun village under Kangchup Police Station, Kangpokpi District to destroy poppy plants by a combined security forces comprising Kangpokpi District Police led by SP/KPI and his escort, ASP/KPI and his escort, SDPO-NKM and his escort, teams of Kangchup Police Station and NKM-PS, a column (1-1-14) of 19 AR, 2(two) platoons of 30 BN CRPF, 2(Two) sections of G-86 and 1(one) section of F-86 BN CRPF and 2(two) sections of 69 BN CRPF.

During the operation, approximately 25 (twenty five) acres of poppy cultivated field was detected in the interior of Awlmun village. The combined team reached at the spot at about 8:30 am and started destruction the illicit poppy plants. The poppy plants were found in growing stages and few in flowering stages. Plucked 3(three) poppy pod/flowering top as representative samples which were put inside 3(three) separate brownish paper envelopes marked as A'1 and A'2 as parent sample and duplicate sample and another 1(one) poppy pod/flowering top as parent seizure also put inside a brownish paper envelope marked as "A". The paper envelopes were

seized in presence of the witnesses. The operation for destroying/cutting of illicit poppy plants was concluded at 02:15pm. Photographs were taken for adducing evident when require in the Court of law.

During the operation, 08(eight) farmhuts amidst the poppy cultivated field were burnt down. 02(two) full of bags suspected to be Urea fertilizer, 03(three) partially filled sacks suspected to be DAP fertilizers were found at the poppy cultivated field and destroyed after collected sample in different small plastic bags and seized in presence of the witnesses.

Today i.e 12/11/2025 at about 06:00 am an operation was launched at Awlmun village under Kangchup Police Station, Kangpokpi District to destroy poppy plants by a combined security forces comprising Kangpokpi District Police led by SP/KPI and his escort, ASP/KPI and his escort, SDPO-NKM and his escort, teams of Kangchup Police Station and NKM-PS, a column (1-1-14) of 19 AR, 2(two) platoons of 30 BN CRPF, 2(Two) sections of G-86 and 1(one) section of F-86 BN CRPF and 2(two) sections of 69 BN CRPF.

During the operation, approximately 25 (twenty five) acres of poppy cultivated field was detected in the interior of Awlmun village. The combined team reached at the spot at about 8:30 am and started destruction the illicit poppy plants. The poppy plants were found in growing stages and few in flowering stages. Plucked 3(three) poppy pod/flowering top as representative samples which were put inside 3(three) separate brownish paper envelopes marked as A'1 and A'2 as parent sample and duplicate sample and another 1(one) poppy pod/flowering top as parent seizure also put inside a brownish paper envelope marked as "A". The paper envelopes were seized in presence of the witnesses. The operation for destroying/cutting of illicit poppy plants was concluded at 02:15pm.
