

Sir,

I have the honour to report that today i.e. the 3<sup>rd</sup> January, 2026 at about 2:00 p.m. received a reliable information from our own source corroborated with the intelligence of 31 AR about the presence of some anti-social elements suspected to be woman active members of the outfit KCP at Lairikyengbam Leikai area of Imphal-East District. Based on the said information and with the permission/authorization of the authority, teams of CDO/IE along with woman police personnel conducted a searched operation at the said area under the command of Inspt. Anilchandra Mutum, Officer-in-Charge CDO/IE Unit and under the supervision of Shri. Y. Joyraj Singh, MPS Addl. SP(Ops)IE and under the overall supervision of Shri. Shivanand Surve, IPS, Superintendent of Police Imphal East District at 3:00 p.m.

In that, one suspicious unknown woman was detained for spot verification at a house at Lairikyengbam Leikai, Salan Leirak, Imphal East District. On verification, the detainee identified herself as one **Nongthongbam Sarjubala Devi @ Watembi (29 years) W/o L. Romen Singh of Lairikyengbam Leikai, Salan Leirak, Imphal East District**. On further verification, the detainee stated that she is an active member of the outfit KCP (TaibangNganba) group joined through one Mr. Malem of KCP (TaibangNganba) in the month of June, 2024 and presently working under the command of one Mrs. Lanchenbi of KCP (TaibangNganba).

So, the detainee was arrested from her residence i.e. Lairikyengbam Leikai, Salan Leirak, Imphal East District at 3:20 p.m. by observing due formalities.

Therefore, the arrested person is being handed over to you for taking up further necessary legal actions against her.
