I was approached by 7(Seven) unknown masked person asking for photograph after my performance with my music band, The Dirty Strikes at the festival. Without any provocation I was attacked by some unknown persons specifically targeting my head and face with unknown weapons. This appeared to be a life attempt on my life. Upon raising a loud alarm for help by a friend, Kennyson Laitonjam, the assailant fled the scene and it was at around 9:30 pm. Although several witnesses at the festival entrance attempted to pursue the attackers they managed to escaped taking advantage of the darkness.

I would like to report and request an investigation into whether this was an act of co-ordinate effort to suppress the artistic freedom through fear and violence.




