FIR Contents :- The complt. Namely SI Md. Akbar Shah of HNG-PS lodge a written report to OC HNG-PS stating that today i.e 14/01/2026 at around 11:30 pm, a combing and search operation was conducted in connection with the upcoming Republic Day celebration,2026 as part of intensified security measures. The operation was led by led by Inspt. H. Sachindra Singh OC/HNG-PS assisted by the teams of Miss Reema Haobam, MPS, SDPO-NCC, two teams of HNG-PS and E/104 Bn BSF station at HNG-PS, IE under the command of Shri AK Sadananda Singh, Addl SP TCP/IE vide No. IC/11(107)/2025-PHQ/8794 dated 29 December, 2025 and under overall supervision of Shri Shivanand Surve, IPS, SP/IE. During the operation the area Khomidok Masjid Maning was cordoned and a systematic house to house search was carried out. While searching one residential house situated at Khomidok Masjid Maning, IE banned contraband substance suspected to be WY tablets were found concealed in wooden rack below the stair case inside two black pouches, further wrapped in a black polythene. On enquiry at the spot, it came to light that the said house belongs to Md. Bashir aged 39 yrs S/o Md. Amu of Khomidok Masjid Maning, IE and his wife Sajida (33) Yrs W/o Md. Bashir. Both are involved in drugs selling/trafficking, however both were not found in the house at the time of search. The search and seizure were conducted in the presence of independent witnesses after explaining the purpose of search. The recovered substance was seized, sealed and labelled at 12:19 a.m. on the spot following due procedure and kept in a yellow envelope marked as "A". That on conventional weighing of all the seized drugs it is found to be 54 grams including the weight of the two black plastic pouches. Further, one two-wheeler Hero Honda Glamour bearing registration number MN01D/1786 was also seized from the campus of the same house. Therefore, the seized items is being handed over to OC Heingang Police station for taking up necessary legal action against him. Henc the case.


