

Petersony Singh**, 2 i/c Reserve Line, Imphal East District Police lodged a written report to OC/HNG PS stating that on 20th January, 2026 at about 8:30 a.m. received a reliable information from our own source about the presence of an active cadre of the outfit NSCN (IM) Mantripukhri area of Imphal East. Based on the said information and with the permission/authorization of the authority, a combined team of CDO/IE Unit and RL, Imphal-East District Police conducted a random frisking and checking to the suspected passersby at Mantripukhri Bazar under the command of Inspt. Anilchandra Mutum, Officer-in-Charge CDO/IE Unit and Inspt. Kh. Bobocha Singh, Reserve Inspector Imphal East District, supervised by Shri. Y. Joyraj Singh, Addl. SP(Ops) IE and under the overall supervision of Shri. Shivanand Surve, IPS, Superintendent of Police Imphal East District at 9:20 a.m.

In that, one unknown suspicious person who came in one motorcycle was detained for spot verification and checking at Mantripukhri Bazar, Imphal East District. On checking the detainee body, one wallet and one sling bag containing one .32 Pistol loaded with four live rounds in the magazine, two nos. of mobile phones, one vehicle Manual Book along with one Cash Memo receipt and one phone charger were recovered from his possession. On verification, the detainee identified himself as one **Lanlungba Khumba @ Alan @ Gwang (29 years) S/o (Late) Sangam Khumba of Waphong Itham Village, Kangpokpi District**. On further verification, the detainee stated that he is an active member of the outfit NSCN (IM), joined through one Mr. Sajangba Ramroi of NSCN (IM) in the year 2012 and got his basic military training for four months at Dimapur, Nagaland under the command of one s/s – Second Lieutenant Mr. Angam with allotted army no. 4290094. The detainee further stated that he is presently holding the rank of s/s – Sergeant Major working under the command of one s/s – Lieutenant Mr. Peace of NSCN (IM).
