(4) The combined acts of firing multiple gunshots and leaving a specific, organisation-claimed threat note unequivocally demonstrate their intent to cause my death and terrorize my family. (5) As a consequence of the firing, one projectile struck and injured his pet dog which sustained a bullet wound to its leg. (6) This act of targeted violence and intimidation has created an atmosphere of extreme fear and insecurity for his and their family, and they now face a clear and imminent. Hence the case.



my residence.**

Sir,

I, the undersigned, Shankar Thokchom S/o (L) Bihari Thokchom a resident of Kairang Makha Leikai, Lane No. 3, Gate No. 8, Imphal East, wish to bring the following serious incident to your immediate notice and request urgent and necessary legal action.

1. On 18th October 2025 at approximately 11:27 pm, my residence at the aforementioned address was targeted by unknown miscreants.
2. The assailants opened fire at my house. From a preliminary review of the CCTV footage installed at my premises, it is confirmed that a total of three (3) rounds of bullets were fired.
3. Furthermore, the miscreants also threw a threatening chit (letter) onto my property. This chit contains a direct death threat and is purportedly issued by the RFP/PLA Finance wing.
4. The combined acts of firing multiple gunshots and leaving a specific, organisation-claimed threat note unequivocally demonstrate their intent to cause my death and terrorize my family.

Therefore, I earnestly request your office to –

- **Register a formal FIR under the appropriate and stringent sections of the BNS, Arm Act and other relevant security laws.**
- **Initiate an immediate and thorough investigation into the incident.**
- **Provide necessary security and protection for me and my family, given the grave and specific nature of the threat from an outlawed organisation.**
