One Jem. N. Nunghsi Babu Singh, JC no. 916 of 7th IRB Now attached with CDO/IE Unit lodge a written report to OC HNG-PS stating that today i.e., the 27th December, 2025 at about 2:30 a.m. received a reliable information from our own source corroborated with the intelligence of 28 AR about the presence of some anti-social elements at Haotan area of Imphal East District. Based on the said information and with the permission/authorization of the authority, team of CDO/IE Unit conducted a C.I. Ops. at the said area under the command of Inspt. Anilchandra Mutum of OC-CDO/IE Unit, supervised by Shri. Y. Joyraj Singh, Addl. SP(Ops) IE and under the overall supervision of Shri. Shivanand Surve, IPS, Superintendent of Police Imphal East District at 3:30 a.m. In that, one unknown suspicious person was detained for spot verification at a house at Haotan Thangjam Khunou, Heingang PS, Imphal East. On verification, the detainee identified himself as one Aribam Gunindro Sharma (30 years) S/o A. Naobi Sharma of Haotan Thangjam Khunou, Heingang PS, Imphal East District. On further verification, the detainee stated that he kept conceal some rifle ammunitions at his house. On the instance and pointing of the detainee, (i) 12 (twelve) nos. of 7.62 x51 mm rifle ammunitions, (ii) 1 (one) no. of .303 rifle ammunitions and (iii) 3 (three) nos. of 12 bore empty case ammunitions were found and recovered from a plastic storage box from inside his room. On further verification, the detainee stated that the recovered ammunitions were handed over to him by one (Late) Mr. Somenkumar and advice him to kept conceal. So, the detainee was arrested from his residence i.e, Haotan Thangjam Khunou, Heingang PS, Imphal East at 4:12 a.m. and seized; (i) 12 (twelve) nos. of 7.62 x51 mm rifle ammunitions, (ii) 1 (one) no. of .303 rifle ammunitions and (iii) 3 (three) nos. of 12 bore empty case ammunitions at the spot i.e. Haotan Thangjam Khunou, Heingang PS, Imphal East at 4:15 a.m. by observing due formalities. 



Sir,

I have the honour to report that today i.e., the 27th December, 2025 at about 2:30 a.m. received a reliable information from our own source corroborated with the intelligence of 28 AR about the presence of some anti-social elements at Haotan area of Imphal East District. Based on the said information and with the permission/authorization of the authority, team of CDO/IE Unit conducted a C.I. Ops. at the said area under the command of Inspt. Anilchandra Mutum of OC-CDO/IE Unit, supervised by Shri. Y. Joyraj Singh, Addl. SP(Ops) IE and under the overall supervision of Shri. Shivanand Surve, IPS, Superintendent of Police Imphal East District at 3:30 a.m.

In that, one unknown suspicious person was detained for spot verification at a house at Haotan Thangjam Khunou, Heingang PS, Imphal East. On verification, the detainee identified himself as one **Aribam Gunindro Sharma (30 years) S/o A. Naobi Sharma of Haotan Thangjam Khunou, Heingang PS, Imphal East District**. On further verification, the detainee stated that he kept conceal some rifle ammunitions at his house. On the instance and pointing of the detainee, **(i) 12 (twelve) nos. of 7.62 x51 mm rifle ammunitions, (ii) 1 (one) no. of .303 rifle ammunitions and (iii) 3 (three) nos. of 12 bore empty case ammunitions** were found and recovered from a plastic storage box from inside his room. On further verification, the detainee stated that the recovered ammunitions were handed over to him by one (Late) Mr. Somenkumar and advice him to kept conceal. Since then, he have been kept concealing the said ammunitions at his house and looking for a willing buyer so that that he might sell the ammunitions at an extortionate price.

So, the detainee was arrested from his residence i.e. Haotan Thangjam Khunou, Heingang PS, Imphal East at 4:12 a.m. and seized; **(i) 12 (twelve) nos. of 7.62 x51 mm rifle ammunitions, (ii) 1 (one) no. of .303 rifle ammunitions and (iii) 3 (three) nos. of 12 bore empty case ammunitions** at the spot i.e. Haotan Thangjam Khunou, Heingang PS, Imphal East at 4:15 a.m. by observing due formalities.

Therefore, the arrested person along with the seized items is being handed over to you for taking up further necessary legal actions against him.
