Today, i.e. 17/10/2025 at 7:30 pm received a reliable information that on the same day at about 7:10 pm, 2(two) unknown persons i.e. one person wearing Police Uniform and the other person in civil dress creating nuisance and disturbing to the general public located at Khurai Ahongei Irabot Leirak by demanding money from the lagao(dice) players. Accordingly, a team of Porompat Police Station rushed to the said areas and the two unknown persons were detained at the spot i.e. Khurai Ahongei Irabot Leirak for verification. On verification, they identified themselves as (1) Kh. Anish Iqbal aged about 30 years S/o Md. Hesamuddin of New Lambulance, River Bank, Imphal East and (2) MK. Amir Rahaman 33 years S/o Md. Abdul Rahaman of Hata Mana Ingkhol, Imphal East who were involving in demanding of money from those persons who were playing Lagao (dice) by impersonating themselves as an Assistant Sub-Inspector of Motor Vehicle Transport. On further checking one fake identity card of assistant sub-inspector of Manipur vehicle department in the name of Kh. Anish Iqbal was recovered from Kh. Anish Iqbal. That the act of above mention persons is in violation of Police uniform with intention


