12. First Information Contents:

Today i.e. 21/11/2025 at 11.10 am received an information that on the same day at about 11.05am large numbers of unruly mob numbering about 400/500 IDP'S staying at the Sajiwa relief camp and Sawombung relief camp were gathered at Khurai Laikhulembi Community Hall. Thereafter, the unruly mob started protest march towards Lamlong Bazar side for protesting against the ongoing Sangai Festival, 2025 at Hapta Kangjeibung which is to be organized by state Government of Manipur. In That, the Police personnel who were on duty at Khurai Sajor Leikai near IMA Laikhulembi Community Hall tried to stop the unruly mob and request them to returned at their residence in violation of the prohibitory order issued by the District Magistrate Imphal East. Suddenly, instead of Police warning the unruly mob started pelting stone catapults towards the police personnel, who were on at the spot. That, the Police personnel warned them to stop their action. But despite of the Police warning, the mob became more violent towards the Police personnel and obstructed the police personnel including the Officers who were discharging their legal duty. During mob control suddenly the unruly mob forcefully abducted a Police officer Shri Maibam Digbijoy Meetei MPS SDPO-PRT and assaulted a police personal. The unruly mob taken hostages SDPO/PRT and detained at Sajiwa Relief Camp. In the incident the Superintendent of Police Imphal East District, Manipur was also injured on his head due to pelted stone by the unruly mob., After taking permission from the concerned Executive Magistrate, the police team had to resort to fire some rounds of tear smoke/ tear gas shells as well as mild lathi charge towards the rioters to disperse the mob by observing necessary formalities with due law, and the injured police personal was evacuated to JNIMS Hospital Porompat for medical treatment.

Hence a suo-mottu case under FIR No. 298(11)2025 PRT-PS u/s 191(2)(3)190/132/118(2) BNS-2023 has been registered for investigation.
