12. First Information Contents:

Today, i.e., 04/12/2025, at around 08.40 AM, it came across through social media post a viral circular notice with the heading Apunba Cherol (Joint Notification) dated 03/12/2025 of G-5, a conglomerate of five ban militant outfits of Manipur comprising of KCP (Kangleipak Communist Party), KYKL (Kanglei Yawol Kanna Lup), PREPAK (People's Revolutionary Party of Kangleipak), PREPAK PRO (People's Revolutionary Party of Kangleipak, Progressive) and UNLF (United National Liberation Front). The joint notice of the banned outfits signed by H. Ibomcha (KCP), C. Lanngamba (KYKL), Ch. Malemnganba (PREPAK), L. Ibochouba (PREPAK PRO) and Ksh. Yoihenba (UNLF) declared that the Sangai Festival of Manipur, 21st Nov, 2025 to 30th Nov, 2025 was banned by IDP's (Internally Displaced Person's) who has been taking refuge in Relief camps since 3rd May, 2023 due to the terrorist acts and atrocities of the Chin-Kuki Narco Terrorist. It is pertinent to mention that the initial boycott call for the Sangai Festival 2025 was publicly issued by COCOMI, which resulted in widespread mobilisation, obstruction, protests, attempts to block cultural events, intimidation of artists and stall owners, and severe law & order disturbances across Imphal between 21st and 30th November 2025.

The present G-5 notification appears to capitalize on the earlier boycott atmosphere and further escalate fear, intimidation, and coercion among the civilian population and further the notification declares to punish those who participate in the Sangai Festival Manipur, 2025 including artist, business enterprise, professionals, stall owners and others as passed in the joint meeting of G 5 held on 28th Nov., 2025. The resolution of the meeting is as follows; -

1. Sana Leibak Nachom Artist Association, Chumthang Creative Artist Association, Kamakhya Sangeet Mandal and Samadon Artist Association, who participated in the Sangai Festival 2025 against the interest of the general public, are hereby banned from performing for a period of one year, i.e., from 10th Dec, 2025 to 10th Dec., 2026.
2. The present President of the Manipur State Sumang Leela Council, namely Laishram Tomba, and the lifetime Secretary, Sougrakpam Hemanta @ Tolhan, are hereby banned for a period of three years, i.e., from 10th Dec., 2025 to 10th Dec., 2028, from participating in any Sumang Leela activities or engaging in any work related to Sumang Leela.
3. The present President of the Manipur State Sumang Leela Council, namely Laishram Tomba, and the Lifetime Secretary, Sougrakpam Hemanta @ Tolhan, shall tender their resignation from their respective posts on or before 10th Dec., 2025.
4. All the reactionary artists working as government collaborators of the Sangai Festival, including business enterprises, professionals, stall owners, and individuals who participated in the festival, shall tender a public apology for the act committed against the Meitei community on or before 10th Dec., 2025.

As such the notification of the banned militant's outfit G-5 directly promotes and engage in credible threats, violence, terrorism, propaganda, criminal activities of the outfits. Circulating such threatening and alarming notification amounts to dissemination of extremist ideologies through media, or acts of violence intended to cause fear to the general public, spread extremist propaganda, radicalize individuals, and enhance the impact of terror acts. The contents of the notification of G-5 also directly challenge the functions of the Government and likely to threaten the unity, integrity, sovereignty or security of India with intent to strike terror.

The circulation of such a threatening and alarming notice by banned militant groups clearly attracts the provisions of the Unlawful Activities (Prevention) Act, including offences related to terrorist acts, membership/support of banned organisations, and dissemination of extremist propaganda. Hence, a Suo-Mottu case under FIR No. 308(12)2025 PRT U/S 61(2)/351(2)(3)/352/353(2) BNS, 2023 & 16/20 UA(P) Act has been registered for investigation.


