## Sub :- Report.

Sir,

I have the honour to report that today i.e. the 4th December, 2025 at about 2:30 p.m. received a reliable information from our own source corroborated with the intelligence of 2 JAK LI (Jammu And Kashmir Light Infantry) about the presence of an active cadre of the outfit PREPAK (Pro), an alliance of GS, at Khurai-Lamlong area of Imphal East District. Based on the said information and with the permission/authorization of the authority, teams of CDO/IE Unit conducted a CL. Ops. at the said area under the command of Inspt. Anilchandra Mutum, Officer-in-Charge CDO/IE Unit, supervised by Shri. Y. Joyraj Singh, Addl. SP(Ops) IE and under the overall supervision of Shri. Shivanand Surve, IPS, Superintendent of Police Imphal East District at 3:30 p.m. In that, one unknown suspicious person was detained for spot verification and checking Khurai Chaithabi Leirak near SHAIBO Hospital, Imphal East. On verification, the detainee identified himself as one, Wangkhem Malemnganba Meitei Iago Ngaionba (30 years) S/o London Wangkhem of Sabungkhok Khunou Mayal Leikai, Yaingangpokpi PS, Imphal East District. On further verification, the detainee stated that he is an active cadre of the outfit PREPAK (Pro), an alliance of GS, joined through one Mr. Khaba of PREPAK (Pro) in the month of October, 2024 and got his basic military training at Heirok Ingangliou, Thoubal District for 40 days with allotted army no. 117 of 2nd batch of the year 2021 under the command of one Mr. Satpa of PREPAK (Pro). The detainee further stated that, after completion of his basic military training, he is staying at Thammnapokpi Camp, Imphal East District presently working under the command of ones/s-Camp Commander Mr. Khaba of PREPAK (Pro), an alliance of GS. So, the detainee was arrested from the spot i.e. Khurai Chaithabi Leirak near SHAIBO Hospital, Imphal East at 3:55 pm by observing due formalities.

Therefore, the arrested person is being handed over to you for taking up further necessary legal actions against him.
