Sir,

I have the honour to report that today, i.e. 09/12/2025 at about 01:00 AM, based on a reliable information provided by ANTF Imphal East and further corroborated by FGT Imphal BSF regarding the presence of drug traffickers and a huge consignment of contraband items in the presence of drug traffickers and a huge consignment of contraband items at the residence of one Yumkhaibam Nasir (65) yrs, S/o (L) Karimuddin of Kshetrigao Sabal Leikai, Imphal East District. The said information was reduced in writing and was placed before Sri. AK. Sadananda Singh, Addl. SP (Traffic) Imphal-East (Nodal Officer ANTE Imphal-East) for execution the information into action.

I obtained authorisation to search the premises of Yumkhaibam Nasir (65) yrs, S/o (L) Karimuddin of Kshetrigao Sabal Leikai from Addl. SP (Traffic) Imphal-East.

On approval of the source report, a joint team comprising of personnel from CDO Unit Imphal East, ANTF/Imphal-East, FGT Imphal BSF and GD Personnel team of 164 Bn BSF was constituted for execution of the secret information. Accordingly, the search operation was launched under the supervision of Dhiraj Karan Khumanthem, DSP (Ops) Imphal-East and the detailed teams proceeded towards the target locations from 01:30 hrs. The Joint team was instructed to conduct search at the above noted house from 01:50 hrs of 09/12/2025.

On reaching the residence of Yumkhaibam Nasir (65) yrs, S/o (L) Karimuddin of Kshetrigao Sabal Leikai, the teams started the search operation and during the search, cash amounting to 5,09,000/- (Rupees Five Lakhs and Nine Thousand only) in 980 Nos. of ₹500 denomination notes, 50 Nos. of ₹200 denomination notes, 79 nos. of ₹100 denomination notes and 22 nos. of ₹50 Denomination notes were recovered from the bedroom of Yumkhaibam Nasir. Further, a black plastic polythene containing 72 (Seventy two) vials of suspected Heroine No. 4 which were kept inside a school bag (red with Grey strip in colour) was recovered. On conventional weighing, the total weight was found to be approximately 104 grams in total (including the weight of the plastic vials container) was properly packed, sealed and labelled as "A". Accordingly, the above 72 (Seventy two) vials of suspected Heroine No. 4, cash which are believed to be proceeds for the sale/purchase of narcotic substances were seized from the possession of Yumkhaibam Nasir (65) yrs, at 02:45 hrs of 09/12/2025.

Accordingly, he was arrested by observing formalities at 02:50 hrs of 09/12/2025 in presence of the witnesses.

It is therefore, the arrested accused person namely Yumkhaibam Nasir (65) yrs, S/o (L) Karimuddin of Kshetrigao Sabal Leikai, Imphal East District along with the seized articles are being handed over to you for taking up further necessary legal action against him.
