

Sir,

I have the honour to report that today i.e., the 13th December, 2025 at about 2.00 p.m. received a reliable information from our own source corroborated with the intelligence of 33 AR about the presence of some woman active members of the outfit UNLF at Top Moirangkampu area of Imphal East District. Based on the said information and with the permission/authorization of the authority, teams of CDO/IE Unit along with woman police personnel conducted a C.I. Ops. at the said area under the command of Inspt. Anilchandra Mutum, OC-CDO/IE Unit, supervised by Shri. Y. Joyraj Singh, Addl. SP(Ops) IE and under the overall supervision of Shri. Shivanand Surve, IPS, Superintendent of Police Imphal East District at 3:00 p.m.

In that, two unknown suspicious woman were detained for spot verification at a house at Moirangkampu Sajeb Makha Leikai, Imphal-East District. Two mobiles phones were found recovered from the possession of the detainees. On verification, the detainees identified themselves as; (i) **Takhellambam Sanathoi Chanu @ Loingakpi @ Sanathoi @ Thoibi (19 years) D/o T. Amuchou Meitie of Tumukhlong Awang Leikai, Thoubal Dam PS, Imphal East** and (ii) **Kongbrailakpam Rameshori Devi @ Langlen @ Buchu (19 years) D/o K. Ramananda Sharma of Moirangkampu Sajeb Makha Leikai, Porompat PS, Imphal East.**

On further verification, of the first detainee, (Sanathoi), she stated that she joined the said outfit through one Miss. Panthoi of UNLF (Koireng), an alliance of G5 in the month of October, 2023 and presently working under the command of the one Miss Mayokyabi of UNLF (Koireng) group, an alliance of G5. On verification of the second detainee (Rameshori), stated that she joined the said outfit through the first detainee Sanathoi in the month of July, 2024 and presently working under her (Takhellambam Sanathoi Chanu) command.

So, both the detainees were arrested from the residence i.e. Moirangkampu Sajeb Makha Leikai near NECC (North Eastern Library Cultural Centre) building, Imphal East District at 3:15 p.m. From the possession of the arrestee, Sanathoi, **one mobile phone (Samsung Galaxy M16) bearing IMEI no.**
