

Sir,

I have the honour to report that today i.e., the 13<sup>th</sup> December, 2025 at about 1:00 p.m. received a reliable information from Technical Intelligence Unit of Commando Imphal East District about the presence of some anti-social elements at Porompat Pangal Leirak area of Imphal East District. Based on the said information and with the permission/authorization of the authority, teams of CDO/IE Unit conducted a searched operation at the said area under the command of Shri. Kh. Dhiraj Karan, MPS, Dy. SP(Ops) Imphal East, supervised by Shri. Y. Joyraj Singh, Addl. SP(Ops) IE and under the overall supervision of Shri. Shivanand Surve, IPS, Superintendent of Police Imphal East District at 2:00 p.m.

In that, one unknown suspected person was detained for spot verification and checkiga at Porompat Pangal Leirak near Star Sporting Club playground, Porompat PS, Imphal East District. On checking, one mobile phone was found and recovered from his possession. On spot verification, the detainee identified himself as one **Baseimayum Yaibi (55 years) S/o B. Karimuddin of Porompat Pangal Leirak, Porompat PS, Imphal East.** On further verification, the detainee stated that he is an illegal drug smuggler and he has been smuggling drugs for the last one year. On further verification, our CDO team learnt that he kept conceal 7 (seven) nos. of soap case containing heroine no. 4 powder at the bank of the pond located at south-western side of the Star Sporting Club, playground, Pangal Leirak, Porompat PS, Imphal East District. Immediately, on the pointing and instance of the detainee, 7 (seven) nos. of soap case containing inside one black plastic polythene were recovered. The detainee further stated that the recovered heroine no. 4 powders were handed over to him today by one Mrs. Wahida Begum of Kwakta for selling to some illegal willing buyers.

So, the detainee was arrested from the spot i.e. Porompat Pangel Leirak, near Star Sporting Club group, Imphal East District at 2:23 p.m. and seized **7 (seven) nos. of soap case suspected to be containing Heroin no. 4 powder and one mobile phone (HMD) bearing IMEI no.**
