I have the honour to report that today i.e 16th December 2025 at around 7.30pm one named Konthoujam Jittankumar Singh 29 Years s/o K. Raghupati Singh of Khurai Ahongei coming in a four wheeler vehicle (NO:AW 8471) had criminally trespassed into my house located at Khurai Thangjam Leikai and physical assaulted my wife namely Thangjam ongbi Sarju Devi and my son namely Thangjam Shyanchand with intent to kill them while I was not in home without telling any reason. After then Konthoujam Jittankumar had also threatened to my family member that he tried to kill all my family members if my family member does not give my daughter namely Sarjalata. Earlier in the last years, he had frequently harassment to my daughter physically and mentally and to my family member by threatening and by using slang word to us through calling to my daughter phone. As a result of which, my wife and my son sustained injury on their persons and evacuated to JNIMS Hospital for medical treatment.

It is therefore, requested to kindly take up necessary legal action against the perpetrators at the earliest.
