Sir,

I have the honour to state that on 19/12/2025 at around 12:40 pm combined team of District Police Imphal East comprising of SDPO(PRT), SDPO (NCC) DSP(Ops), OC-PRT PS, OC-HNG, OC-CDO, 2ic-CDO, Anti narcotic Task force (ANTF) Imphal East, M&N sector CRPF, Range Imphal QAT CRPF, DETT 232 (Mahila) Bn CRPF, B/232 (Mahima) CRPF, CDO IE under the command of Shri Y. Joyraj Singh, Addl. SP (OPS) and Shri Ak. Sadananda Singh, Addl. SP (Traffic), and overall supervision of Shri Shivanand Surve, IPS, Superintendent of Police, Imphal East conducted CASO at Khergao Yumkhaibam Makha Leikai.

During the search of one residential house located at Khergao Yumkhaibam Makha Leikai, 12 soap cases containing suspected heroin no 4 powder were found concealed in a black polythene packet inside the garage/godown on the ground floor. On verification the house belongs to Yumkhaibam Ajmir @ Ezi, a resident of the same locality. However he was not found at home during the search. His wife **Syed Nizia Sultana @ Abema 38yrs w/o Yumkhaibam Ajmir @ Ezi** was present and detained for verification in the presence of Mahila battalion CRPF personnel Syed Nizia Sultana @ Abema admitted that the suspected heroin no 4 was jointly concealed by her and her husband for sell to prospective buyers. She further disclosed that both had been involved in the smuggling of such contraband substances for the passed two to three years and that the seized quantity was kept hidden by her inside the garage/godown of their house. Accordingly, the detainee Syed Nizia Sultana @ Abema was formally arrested at 3.00 pm on the spot. The following items were seized from her possession after observing all necessary formalities. (1) 12 soap case of suspected heroin no 4. powder (2) one mobile phone bearing JIO mobile no 6009922748, IMEI1-867707051773945 IMEI2-867707051773952 (3) 12 bore DBBL gun bearing gun no. 26166 A/8 by BS Corporation (4) Empty Vial: 3423 in number and (5) Rs 70410 /-(Seventy Thousand Four Hundred Ten) only. During further questioning the accused reiterated that the seized contraband was handed over to her by her husband, Yumkhaibam Ajmir @ Ezi for selling to willing buyers.

Therefore, the arrested accused person namely Syed Nizia Sultana @ Abema 38yrs w/o Yumkhaibam Ajmir @ Ezi of Khergao Yumkhaibam Makha Leikai IE Dist. along with the seized items are hereby handed over to you for taking up further necessary legal action under the relevant provision of law.
