Joyraj Singh, Addl. SP (OPS) and Shri Ak. Sadananda Singh, Addl. SP (Traffic), and overall supervision of Shri Shivanand Surve, IPS, Superintendent of Police, Imphal East conducted CASO at Khergao Yumkhaibam MakhaLeikai.

During the search operation conducted at KhergaoYumkhaibamMakhaLeikai one unknown women was found standing in a very suspicious manner near the gate of one Mrs. Amusana aged about 50 yrs w/o (unknown). On observing her suspicious conduct, personnel of the Mahila Batallion of CRPF, detained her and directed her to move from the spot. While she attempted to move a transparent plastic polythene packet, light blue in colour, containing several blue colour capsule fell from her trouser. She was immediately detained for verification. On spot verification she disclosed her identity as **Khulakpam Farzina @ Jina 33 yrs w/o Yumkhaibam Altaf of Khergao Yumkhaibam Makha Leikai**. On examining the capsules their were found leveled as SPM-PRX A suspected to be SP (Spasmo- Proxyvon) capsules. On further questioning she didn't disclosed the source of the drugs but admitted that she is a drug peddler and has been selling such drugs to willing buyers and dealers.

Accordingly, the said individual was arrested from the spot i.e Khergao Yumkhaibam Makha Leikai, Imphal East District at about 3:40pm and the following seized item were from her possession by observing all necessary formalities. 1) 72 gm of SP capsules (2) one REALME NAZO mobile phone bearing mobile phone JIO No. 9366572048, IMEI1- 860587059208210 IMEI2- 860587059208202.
