I have the honour to report that today i.e. the 20<sup>th</sup> December, 2025 at about 4:00 p.m. received a reliable information from our own source corroborated with the intelligence of 31 AR & 33 AR about the presence of an active member of the outfit PREPAK, an alliance G5, at Mahabali area of Imphal-East District. Based on the said information and with the permission/authorization of the authority, teams of CDO/IE Unit conducted a C.I. Ops. at the said area under the command of Inspt. Anilchandra Mutum, Officer-in-Charge CDO/IE Unit, supervised by Shri. Y. Joyraj Singh, Addl. SP(Ops) and under the overall supervision of Shri. Shivanand Surve, IPS, Superintendent of Police Imphal East District at 5:00 p.m.

In that, one unknown suspicious person was detained for spot verification and checking at Mahabali Kabui Khul, Imphal East District. On checking the detainee body, one mobile phone was found and recovered from his possession. On verification, the detainee identified himself as one, **Konhoujam Priyoranjan Meitei (21) S/o K. Thoiba Meitei of Angtha Mayai Leikai, Andro Police Station, Imphal East District.** On further verification, the detainee stated that he is an active member of the outfit PREPAK, an alliance of G5, joined through one Mr. Loya of PREPAK in the month of November, 2025 and presently working under the command of the said Mr. Loya of PREPAK.

On further verification, the detainee stated that, on the advice of the said Mr. Loya of PREPAK, he is planning to hurl hand grenades at two wheeler vehicle show-rooms located at Singjamei area of Imphal West District for extorting money. He further stated that, he is also involved in recruiting new cadres to their outfit on the advice of the said Mr. Loya of PREPAK.

So, the detainee was arrested from the spot i.e. Mahabali Kabui Khul, Imphal East District at 5:32 p.m. and seized one mobile phone (Galaxy M15 5G) bearing IMEI no. 350814492312863/01 & 350825402312866/01 along with one Airtel SIM card having phone no. 8798196426 from his possession at the spot i.e. Mahabali Kabui Khul, Imphal East District at 5:35 p.m. by observing due formalities.

Therefore, the arrested person along with the seized mobile phone is being handed over to you for taking up further necessary legal actions against him.
