I have the honour to state that today i.e. 23/12/2025 at about 08:10 am, a reliable information was received regarding the presence of some miscreants who are involved in illegal selling of arms and ammunitions in and around Khurai and Kongpal area of Imphal East District with a view to commit prejudicial activities. Based on the information and with the permission of the authority, a team of CDO-IW led by Inspector Gunachandra Chanam, OC-CDO-IW and myself under the command of Shri P. Achouba Meetei, MPS, Dy. SP (CDO), IW and under the supervision of Shri. N. Suraj Singh, MPS, Addl. SP(Ops.)/IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area after giving prior information to Imphal East District Police Control Room and conducted search operation at Khurai area. During that one suspected person was detained at Khurai Tongbram Leirak Machin. On spot verification, the detainee identified himself as Thingujam Suresh Singh (40 yrs.) @ Bimol @ Ibohanbi S/o. Th. Ibocha Singh of Sekmajin Khunou, Kakching District, Manipur a/p at a rented house located at Khurai Tongbram Leirak, Imphal East District, Manipur. From his possession, (i) one .32 pistol marked with "32 7.65" along with one magazine loaded with one round of .32 ammunition and (ii) one Infinix HOT 50 5G mobile handset along with two SIM cards i.e., (a) one Jio SIM card bearing mobile no. 6009187711 (as disclosed by him) and (b) one Airtel SIM card bearing mobile no. 8415883338 (as disclosed by him) were recovered from his possession. On asking about the above recovered .32 pistol, the detainee disclosed that today i.e., 23/12/2025, he took the said pistol from one Dayamoi from Khurai area for illegally selling of the said pistol. Hence, he was arrested from the spot i.e., from Khurai Tongbram Leirak Machin at 09:40 am and the above recovered articles were seized at the spot at 09:46 am by observing formalities. Immediately, as disclosed by the arrestee, the said CDO-IW team along with the arrestee rushed to the house of Dayamoi and as pointed out by the arrestee, Dayamoi was successfully detained at his residence located at Khurai Soibam Leikai who later on identified himself as Moirangthem Dayamoi (39 yrs) S/o. (L) M. Madan Kumar of Khurai Soibam Leikai, Imphal East District, Manipur. On asking about the above seized .32 pistol, he disclosed that today i.e., 23/12/2025, he gave the said pistol to Suresh (the above mentioned arrestee) for illegally selling of the said pistol. He further disclosed that he bought the said pistol from one unknown person by paying a sum of Rs. 40,000/- through one Loya (now expired) at Pukhao Santipur area in around August/September, 2024. Hence, he was arrested from the spot i.e., from his residence at 10:02 am by observing formalities. From his possession, (i) one BAOFENG hand held set along with its charger, (ii) one Samsung Galaxy A05 mobile handset along with one Airtel SIM card bearing mobile no. 8257964360 (as disclosed by him) and (iii) one Aadhaar card bearing no. 7089 1060 0387 were seized at the spot at 10:08 am by observing necessary formalities. Hence, the arrested persons and the seized articles are handed over to you for taking further necessary legal action against them.


