Sir,

I have the honour to state a few words for your kind consideration and further necessary action that on 26/12/2025 at 9:30 AM OC City PS have registered a regular FIR case being FIR NO 128(12)2025 CITY PS U/S 303(2) BNS based on a complaint report filed by one Tayenjam Bijayaluxmi Devi 53 years W/O Pukhrabam Subash Singh of Langthabal Lep Mayai Leikai, Imphal West District, Manipur regarding the stolen of a lady bag black in colour containing a sum of Rs 4000/- from Ema Keithel No.1 Shed No.25. The same had been endorsed to me and arrested an accused person namely Biki Singh (31) S/o Bimol Singh of Jirighat Post Thana, Digle Gaon A/p Hatta near Public Hospital, Imphal-East in connection with the case. On investigation, Prima Facie evidence was well established against the arrested accused person mentioned above punishable under section 303(2) of Bharatiya Nyaya Sanhita 2023. As the arrested accused had committed the offence for the first time and the stolen amount was under Rupees Five Thousand, Charge sheet was submitted in the Court of JMFC-IW-I (Duty Magistrate) by producing the arrested accused person for summary trial against him punishable under section 303(2) of Bharatiya Nyaya Sanhita 2023. It refers to CS No. 45/CITY PS/2025 Dated 26/12/2025. The Hon'ble JMFC, IW-I (Duty Magistrate) remanded him into judicial custody. The arrested accused person along with another accused person namely Rahul Pal 25 Years S/O (L) Raju Pal of Ram Krishna Nagar, Silchar, A/P Khuyathong Pukhri Achouba, Imphal, who had also remanded into Judicial Custody by the Hon'ble JMFC, IW-I (Duty Magistrate) in another case, have been transported to Manipur Central Jail Sajiwa from the residence of the Duty Magistrate located at Utluu, Bishnupur District, Manipur by using our DI vehicle issued by the Department. Unfortunately, on the way between the residence of the Duty Magistrate and Manipur Cental Jail, Sajiwa, the arrested accused person of case FIR No.128(12)2025 City PS U/S 303(2) BNS namely Biki Singh (31) S/o Bimol Singh of Jirighat Post Thana, Digli Gaon A/p Hatta near Public Hospital, Imphal-East had escaped by jumping from our vehicle taking the advantages of traffic congestion while reaching at Hatta Telipati near Traffic island at around 3:30 PM. We tried to chase him with hectic efforts by using all the possible angles but all were in vain as there was no means to use any forces to overpower him due to heavy traffic congestion and crowded area at that time. Further, maximum efforts are on its way to find out the whereabouts of the accused person by sending special sources.

It is therefore requested your good office to take necessary action against him as per law at the earliest.
