Sir,

I have the honour to report that today i.e, the 30th December, 2025 at about 4:30 pm. received a reliable information from own source about the presence of some vehicle lifter at Wangkhei Andro Parking area of Imphal East District. Based on the said information and with the permission/authorization of the authority, a team of RL/IE and CDO/IE Unit led by myself rushed to the said area and conducted a random frisking and checking to the suspected passersby at Wankhei Andro Parking Imphal East under the supervision of Kh. Bobocha Singh, RI/RL-IE and under the supervision of Shri. Y. Joyraj Singh, Addl. SP(Ops) IE and under the overall supervision of Shri. Shivanand Surve, IPS, Superintendent of Police Imphal East District.

In that, one Mahindra Scorpio black in colour without registration number plate was spotted coming towards Andro Parking from Ningthem Pukhri Mapal side i.e, frisking and checking point. The police team stopped the suspected vehicle for checking. On verification, the driver is identified as Thounaojam Sanju Singh @ Naoba (25 years) S/o Th. Sushildev Singh of Nongmeibung Ayangpalli Road, Imphal East District and the occupant is identified as Thounaojam Nilkamal Singh @ Bungo (40 years) S/o (Late) Th. Tomba Singh of Malom Tuliyaime Awang Leikai. Nambol PS, Imphal West District.

On enquiry about the vehicle the detainees were fail to produce the original documents/registration certificates. On further examination, the detainees stated that the vehicle was brought from one Mr. Laishram Sanaton Meitei (41) S/O L. Senapati Singh of Khurai Kongpal Ningthoubung Leikai to sell interest persons.

On further examination of the vehicle, it is found that the vehicle is a Bullet Proof vehicle which is not authorized/issue to general public. Further, the detainees were unable to produce any valid and genuine documents of the vehicle and permission authorization from a competent authority to use/own such a bullet proof vehicle, it is highly suspicious that the vehicle is lifted one.

So, in the above facts and circumstances, both the detainees were arrested from the spot i.e. Wangkhei Andro Parking at 5:15 p.m. and seized viz:- i) one Bullet Proof four wheeler vehicle (Mahindra
