

Subject : Report.

Sir,

I have the honour to report that today i.e. the 14<sup>th</sup> May, 2025 at about 9:00 p.m. received a reliable information about presence of some active members of the outlawed outfit UPPK at Koirengei area of Imphal-East District. Based on the said information, teams of CDO Imphal East under the command of Inspt. Kh. Henery Singh, OC-CDO/IE Unit and under the supervision of Shri Y. Joyraj Singh, MPS Addl. SP(Ops)IE rushed to the said area and conducted a C.I. Ops. at 10:00 p.m. at Khoirengei bazar, Imphal-East District.

In that, two suspicious unknown persons were detained for spot verification and checking at Khoirengei bazar near market shed, Imphal East District. On verification, the detainee identified themselves as; **Ahongshangbam Abinash Singh @ Chingthang (26 years) S/o Ah. Jayenta Singh of Kwak Siphai Mamang Leikai, Bishnupur District. A/p – Koirengei Bazar, Heingang PS, Imphal East District and Chungkham Kiran Singh @ Lepshinba (19 years) S/o Ch. Amu Singh of Khumbong Mayai Leikai, Patsoi PS, Imphal West District. A/p – Koirengei Bazar, Heingang PS, Imphal East District.** On checking their bodies, two nos. of mobile phones were found and recovered from their possession.

On further verification, both the detainees stated that they are active members of the outfit UPPK and presently working under the command of one s/s – Lieutenant Mr. Moirangcha @ Lion of UPPK. The first detainee, **Ahongshangbam Abinash Singh**, stated that he joined the outfit in the month of November, 2024 through one Mr. Manitomba of UPPK and the second detainee, **Chungkham Kiran Singh**, stated that he joined the outfit through one Mr. Lakpa of UPPK in the month of December, 2024. Both the detainees further revealed that on the advice of the said Mr. Moirangcha @ Lion they had extorted a huge amount of money from the general public for raising their party fund.

So, both the detainees were arrested from the spot i.e. Koirengei bazar near market shed, Imphal East District by observing due formalities at 10:20 p.m. From the possession of the arrestee, **Ahongshangbam Abinash Singh**, seized one mobile phone (Realme C21Y) bearing IMEI no. 86948059078130/01 & 86948059078122 /01 along with one Jio SIM card bearing mobile no. 9863885133 and a sum of Rs. 250/- (two hundred and fifty rupees) at the spot i.e. Koirengei bazar near market shed, Imphal East District by observing due formalities at 10:25 p.m. One mobile phone (Infinix X6525) bearing IMEI no. 356848808764007 & 356848808764015 along with two SIM cards bearing mobile nos. Jio-9366314673 & Airtel-8729862900 was seized from the possession of the arrestee **Chungkham Kiran Singh** at the spot i.e. Koirengei bazar near market shed, Imphal East District by observing due formalities at 10:30 p.m.

Therefore, the arrested persons along with the seized mobile phones are being handed over to you for taking up further necessary legal actions against them.
